

RESOLUTION OF THE CITY COUNCIL

No. 389

Approved August 8, 1973

WHEREAS, a vacancy exists in the office of one Councilman from the Fourth Ward, within the City of Providence, caused by the resignation of Joseph F. Prete, Ward Four, on July 6, 1973, and

WHEREAS, the said vacancy did occur more than one hundred and eighty days before the time of holding the next succeeding regular City election, and

WHEREAS, in accordance with the provisions of Section 12, Chapter 832, of the Public Laws of 1940, known as the "Providence Charter Act of 1940", as amended, by Section 1 of Chapter 2864 of the Public Laws of 1951, approved May 1, 1951, it is mandatory that a Special Election, for the purpose of filling such vacancy, be held within ninety days of the date of the occurrence of said vacancy,

NOW, THEREFORE, BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF PROVIDENCE, RHODE ISLAND, that in compliance with the provisions of governing statutes, the said City Council does hereby order a Special Election to be held for the purpose of filling the vacancy in the office of Councilman from the Fourth Ward of Providence, Rhode Island, caused by the resignation on July 6, 1973 of Joseph F. Prete; said Special Election to be held on the first Tuesday, being also the Second (2nd) day of October, 1973; said date being within ninety (90) days from the date of the occurrence of said vacancy, and

BE IT FURTHER RESOLVED, that the Board of Canvassers and Registration and all other officers whose duty it is to prepare for elections are hereby requested to make such preparations for said election as are required by law, and

BE IT FURTHER RESOLVED, that the City Clerk is directed to cause a duly certified copy of this Resolution to be transmitted to the Board of Canvassers and Registration of the City of Providence, Rhode Island; and a duly certified copy of this Resolution be also transmitted to the State Board of Elections and to the Secretary of State.
