
Gentlemen:

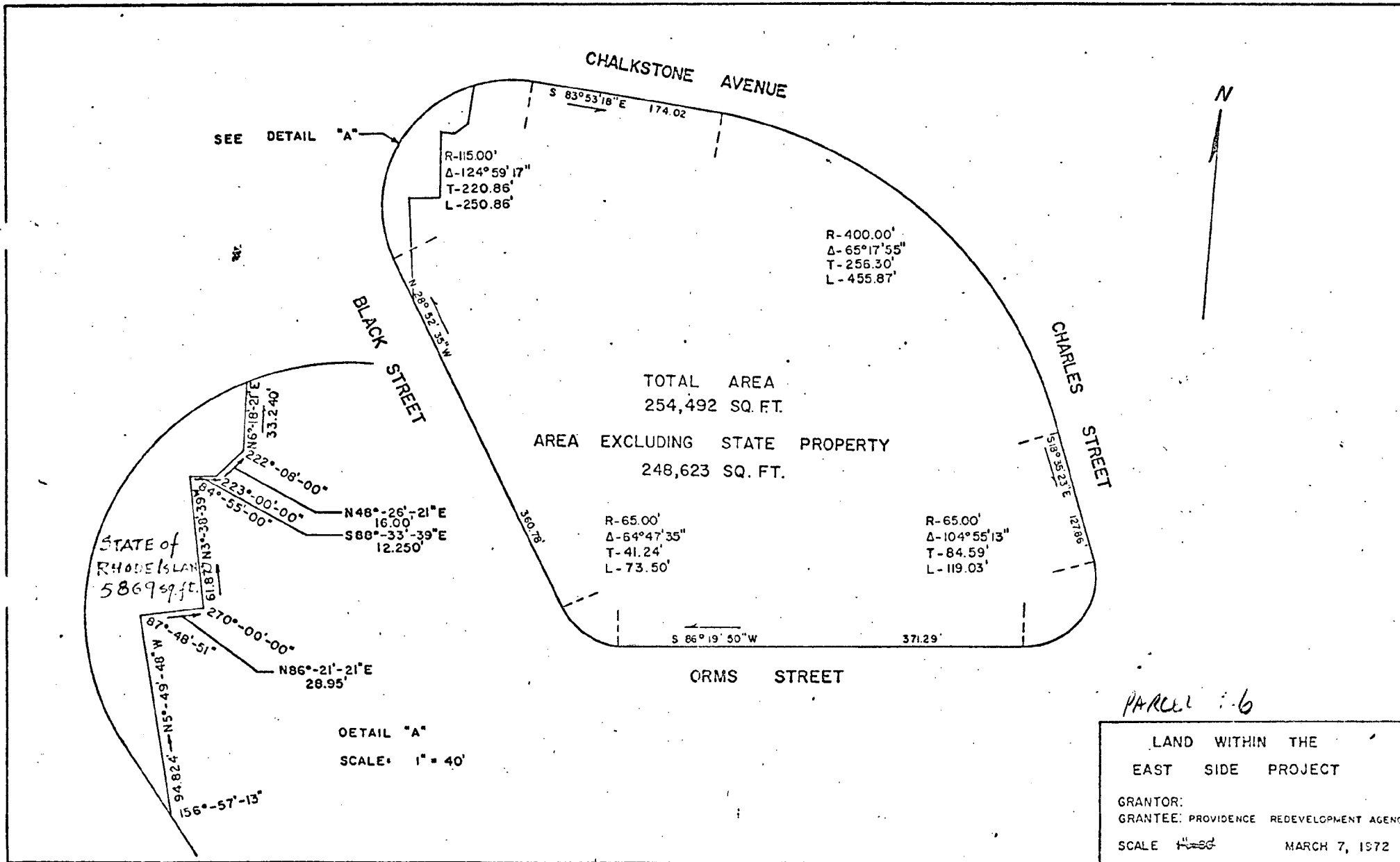

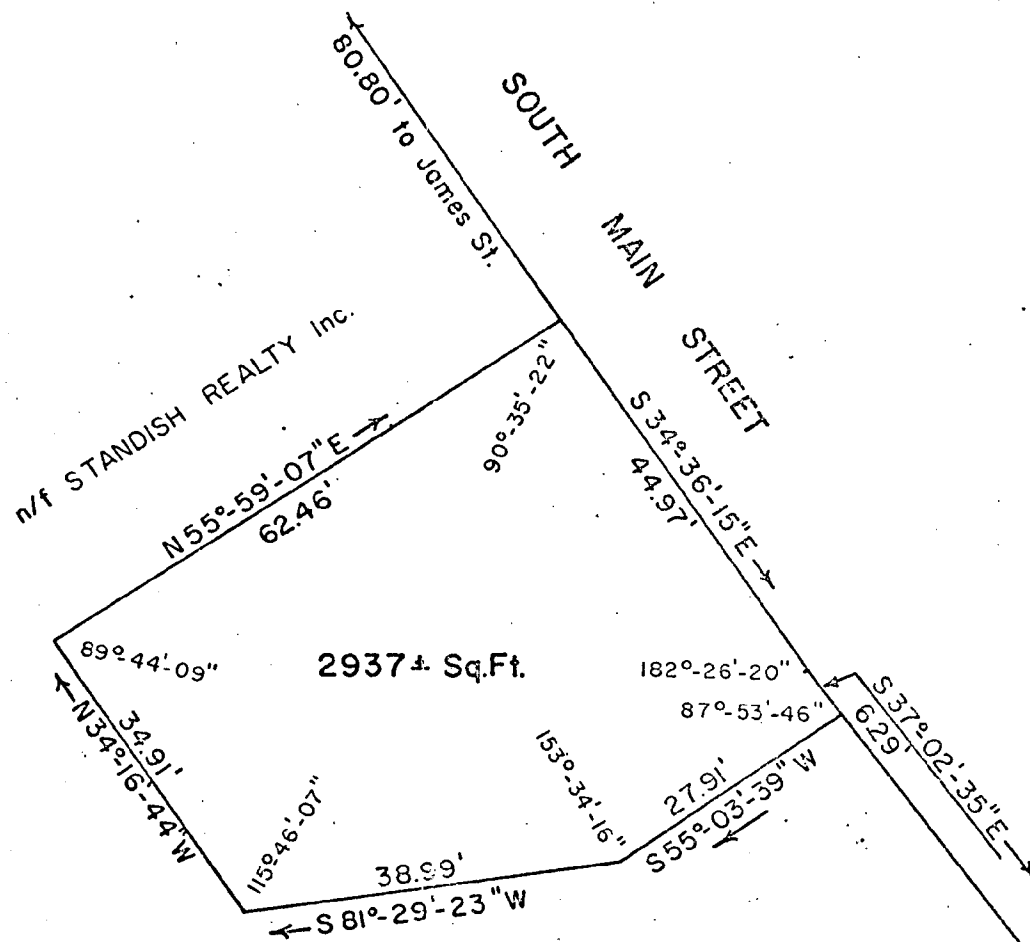
