



CHAPTER 1614

No. 327 AN ORDINANCE AMENDING SECTION 43.2 of CHAPTER 2 of the 1946 REVISED ORDINANCES, ENTITLED, "ADMINISTRATION", AS AMENDED, RELATIVE TO UNIFORM ALLOTMENT IN THE POLICE DEPARTMENT, BY PROVIDING ADDITIONAL ALLOWANCE FOR MOUNTED MOTORCYCLE MEN.

Approved May 22, 1964

Be it ordained by the City of Providence:

SECTION 1. The last paragraph of Section 43.2 of Article III of Chapter 2 of the 1946 Revised Ordinances, as amended, is hereby further amended to read as follows: Subsequent to his first full year of service each uniformed police officer, detective and police driver shall be entitled to receive one hundred five dollars each year, except that mounted motorcycle men shall receive an additional fifty dollars each year. Said sums shall be paid at such times and upon such terms and conditions as may be prescribed by rule or regulation adopted by Commissioner of Public Safety and approved by the City Controller.

SECTION 2. This Ordinance shall take effect upon its passage.



No. 328 AN ORDINANCE AMENDING CHAPTER 1567, "ESTABLISHING A COMPENSATION PLAN FOR THE CITY OF PROVIDENCE", AS APPROVED SEPTEMBER 24, 1963, RELATIVE TO DETECTIVES AND MEMBERS OF THE SO-CALLED C-SQUAD IN THE POLICE DEPARTMENT.

Approved May 22, 1964

Be it ordained by the City of Providence:

SECTION 1. Section 5, Sub-Section 7, Paragraph 3, of Chapter 1567 which now reads as follows:

"Members of the Police Department who are regularly assigned to plain clothes duty as Detectives or members of the so-called C-Squad shall receive in addition to their basic salary an additional six (6%) percentum of their salary during such assignments", is hereby amended to read as follows:

"Members of the Police Department who are regularly assigned to plain clothes duty as Detectives or members of the so-called C-Squad shall receive in addition to their basic salary an additional eight (8%) percentum of their salary during such assignment".

SECTION 2. This ordinance shall take effect upon its passage.



No. 329 AN ORDINANCE PROVIDING CALL BACK PAY FOR CERTAIN MEMBERS OF THE POLICE DEPARTMENT

Approved May 22, 1964

Be it ordained by the City of Providence:

SECTION 1. The following members of the Police Department, namely:

- Police Commander
- Police Captain
- Police Lieutenant
- Police Sergeant
- Police Dog Specialist
- Police Patrolman - Grade 1
- Police Patrolman - Grade 2
- Police Patrolman - Grade 3
- Police Patrolman - Grade 4

- Police Woman - Grade 1
- Police Woman - Grade 2
- Police Woman - Grade 3
- Police Woman - Grade 4

Police Equipment Superintendent

shall be entitled to ^{call} back pay in accordance with the following provisions.

SEC. 2. Call-Back Pay

Officers called back to duty except members regularly assigned to plain clothes duty as Detectives or members of the so-called C-Squad shall be compensated for at least four (4) hours in the event the overtime actually worked is less than four (4) hours, at the rate of pay hereinafter set forth.

SEC. 3. Call-Back Pay

The hourly rate of call back pay shall be equal to one-fortieth (1/40) the employee's weekly salary.

SEC. 4. This ordinance shall take effect upon its passage.




