

# RESOLUTION OF THE CITY COUNCIL

No. 445

Approved June 30, 1993

WHEREAS, Resolution No. 505, approved October 30, 1992, authorized His Honor, the Mayor, to execute a 651.95 square foot easement agreement with Rhode Island Hospital for air rights over Dudley Street, in Providence, Rhode Island, for the sum of THIRTY THOUSAND (\$30,000.00) DOLLARS, for a twenty-five (25) year term with the option to renew for two (2) additional five (5) year terms.

WHEREAS, the Hospital is the owner of such real estate located in the area around Eddy Street in Providence, Rhode Island on which is located its Hospital campus; and

WHEREAS, the Hospital is desirous of having the option to construct up to five (5) other pedestrian walkways over city streets in order to connect buildings on the Hospital's campus so as to provide for safe and protected passage of its employees and patients; and

WHEREAS, the City is desirous of allowing the Hospital to develop its campus and to provide for the protected and safe passage of the employees and patients at the Hospital across city streets; and

WHEREAS, the City is willing to allow the hospital the right to use such air rights upon the following conditions:

- 1.) The Hospital shall pay the City FIVE HUNDRED THOUSAND (\$500,000.00) DOLLARS;
2. The Hospital shall petition the council for a resolution allowing the Hospital the exclusive right to the designated air space;
- 3.) That the walkway is for pedestrian purposes only;
- 4.) That the pedestrian walkway is not injurious to public health, safety or welfare;
- 5.) That the pedestrian walkway is attached to one of Rhode Island Hospital's buildings, or one of its affiliates' building;
6. ) That the pedestrian walkway is within the institutional zone;
- 7.) If the pedestrian walkway is outside the institutional zone, then in addition to meeting zoning requirements and public health, safety or welfare concerns, the council shall take into consideration any adverse impact such walkway may have on surrounding properties;

8. That an insurance certificate in an amount not less than TEN MILLION (\$10,000,000.00) DOLLARS is filed with the City of Providence, listing the City of Providence as an additional party insured for each walkway;

9.) That in addition to an easement agreement being drafted, an indemnification agreement, indemnifying and holding harmless the City, its agents, servants and assigns from any claim, dispute or causes of action whatsoever relative to the rights the City has agreed to grant; and

10.) Any other such terms and conditions as have been imposed by the Committee on City Property, the City Council, the City Solicitor and His Honor, the Mayor and have been memorialized in said documents, approved by the City Solicitor.

NOW THEREFORE, BE IT RESOLVED, that his Honor, the Mayor, is hereby authorized to execute any and all documents with Rhode Island Hospital for a right to exercise an option for up to five (5) pedestrian walkways in consideration for an additional sum of FIVE HUNDRED THOUSAND (\$500,000.00) DOLLARS.





#### RECOMMENDED AERIAL EASEMENT DESCRIPTION

Beginning at a point on the southerly side of Dudley Street, said point being on the northerly property line of land now or formerly of Rhode Island Hospital, said point also being sixty-seven and twenty-five hundredths (67.25) feet east of the southeasterly corner of Dudley Street and Culver Street.

Thence running easterly along the northerly property line of said Rhode Island Hospital land, a distance of twelve and zero hundredths (12.00) feet;

Thence turning an interior angle of  $90^{\circ}-00'-00''$  and running northerly across Dudley Street a distance of fifty and fifteen hundredths (50.15) feet to a point on the southerly property line of land now or formerly of Rhode Island Hospital, said point being on the northerly street line of Dudley Street;

Thence turning an interior angle of  $90^{\circ}-00'-00''$  and running westerly along the southerly property line of said Rhode Island Hospital land, a distance of twelve and zero hundredths (12.00) feet;

RE: Rhode Island Hospital Medical Mall Bridge

This Department has reviewed Rhode Hospital's request for an aerial easement over a portion of Dudley Street. The purpose of this easement is to allow the construction of a connecting bridge between the new Children's Hospital addition and a proposed Medical Mall building.

The Rhode Island State Building Code requires such connections to be segregated from the connecting buildings by fire rated construction and requires that the bridge be constructed of non combustible material. Neither of these requirements are difficult for Rhode Island Hospital to meet. There are no requirements in the Providence Zoning Ordinance that would prohibit the construction of the bridge.

The Public Works Committee should make sure, however, that there is sufficient clearance under the bridge to allow the passage of fire apparatus. I would also recommend that Rhode Island Hospital maintain liability insurance for the structure and name the City of Providence as coinsured.

The City Plan Commission at its June 17, 1992 regular monthly meeting reviewed and evaluated the proposed aerial easement over Dudley Street.

The petitioner is Rhode Island Hospital, who is developing a medical mall on Dudley Street and would like to connected it to the Children's Hospital by a predestrian walkway elevated over Dudley Street.
