ELECTION OF PROVIDENCE MUNICIPAL COURT JUSTICES

COUNCIL PRESIDENT HAXTON calls for nominations for Two Justices of the Providence Municipal Court.

COUNCILMAN FARGNOLI nominates PETER SPINELLA, ESQUIRE, of Providence and this nomination is seconded by COUNCILMEN LYNCH and TURCHETTA.

COUNCILMAN AHERN nominates ROBERT F. ARRIGAN, ESQUIRE, of Providence and this nomination is seconded by COUNCILMEN GLAVIN and LYNCH.

COUNCIL PRESIDENT HAXTON calls for further nominations and there are none.

There being no further nominations, on motion of COUNCILMAN LYNCH, seconded by COUNCILMAN ADDISON, it is voted that nominations be closed and the Clerk be directed to cast on ballot for PETER SPINELLA and one ballot for ROBERT F. ARRIGAN, as Justices of the Providence Municipal Court.

The Clerk casts one ballot for PETER SPINELLA and one ballot for ROBERT F. ARRIGAN, as directed.

COUNCIL PRESIDENT HAXTON thereupon declares PETER SPINELLA, ESQUIRE and ROBERT F. ARRIGAN, ESQUIRE, duly elected as Justices of the Providence Municipal Court for the ensuing terms of Two Years ending on the First Monday in January, 1979.
