AN ORDINANCE IN AMENDMENT OF AND IN ADDITION TO CHAPTER 26 OF THE CODE OF ORDINANCES OF THE CITY OF PROVIDENCE ENTITLED, "WEIGHTS AND MEASURES."


Be it ordained by the City of Providence:

Chapter 26 of the Code of Ordinances of the City of Providence is hereby amended and added to in the following manner:

SECTION I. Section 2607. Fees for loads, vehicles weighed; certificates. The Director of Inspection and Standards shall be entitled to demand and receive from the owner or person weighed by him or her, and such owner or person shall be entitled to receive such reasonable number of certificates of weight as he or she may require for loads or vehicles weighing not more than two thousand (2,000) pounds, the fee shall be ten dollars (\$10.00); for loads or vehicles weighing in excess of two thousand (2,000) pounds and less than ten thousand (10,000) pounds, the fee shall be fifteen dollars (\$15.00); for loads or vehicles weighing at least ten thousand (10,000) pounds and less than twenty thousand (20,000) pounds, the fee shall be twenty dollars (\$20.00); for loads or vehicles weighing at least twenty thousand (20,000) pounds and less than fifty thousand (50,000) pounds, the fee shall be thirty-five dollars (\$35.00); for loads or vehicles weighing fifty thousand (50,000) pounds or more, the fee shall be fifty dollars (\$50.00).


