PRESENTATION OF RESOLUTIONS

COUNCILMAN FARMER (By Request):

Resolution Authorizing the City Council of the City of Providence, Rhode Island to file an Application for Funding under the Jobs Bill (P.L. 98-8).

Whereas, The City of Providence is eligible to receive funds under the recently passed Jobs Bill (P.L. 98-8), and

Whereas, These funds will supplement the Community Development Block Grant entitlement allocation, and

Whereas, A need exists in the City of Providence to create additional jobs and improve the local economy, and

Whereas, The Application for funding shall be filed with the Boston Area Office of the Federal Department of Housing and Urban Development as soon as possible,

Now, Therefore Be It Resolved, That the City Council of the City of Providence, County of Providence, State of Rhode Island, hereby authorize the City of Providence through its official representative, the Mayor, to file an Application for Funds with the Boston Area Office of the Department of Housing and Urban Development for the purpose of obtaining supplemental Community Development Block Grant funds through the so called Jobs Bill (P.L. 98-8).

COUNCILMAN GLAVIN moves the Resolution be Denied.

This motion being seconded by **COUNCILMEN O'CONNOR** and **EASTON** is Put to Vote and Not Passed by the following Roll Call Vote:

COUNCILMAN O'CONNOR moves the Resolution be amended by inserting in Paragraph 5, last line, following; "(P.L 98-8)" the period be deleted and the following added:

"with the following specifications and limitations that, the Jobs Bill budget be adhered to, subject to the Home Rule Charter, as is the regular city budget, and that the City Council shall have the same powers and controls as applied under the Home Rule Charter, and further that transfers be subject to the same conditions pursuant to section (B) of the certifications herein attached".

This motion being seconded by **COUNCILMAN GLAVIN** is Put to Vote and Not Passed by the following Roll Call Vote:

Resolution Authorizing the City Council of the City of Providence, Rhode Island, to file a Statement of objectives and funding under the Housing and Community Development Act.

Whereas, The City of Providence is eligible to receive Community Development Block Grant Entitlement Funds for fiscal year 1984, under Section 106 (a) or (h) of Title I of the Housing and Community Development Act of 1974 and 1980 (Public Law 93-383), and

Whereas, The Statement of Objectives and Funding shall be filed with the Boston Area Office of the Department of Housing and Urban Development as soon as possible,

Now, Therefore, Be It Resolved, That the City Council of the City of Providence, County of Providence, State of Rhode Island, hereby authorize the City of Providence, through its

official representative, the Mayor, to file a Statement of Objectives and Funding with the Boston Area Office of the Department of Housing and Urban Development for the purpose of obtaining Community Development Block Grant Funds.

COUNCILMAN FARMER moves the Resolution be Read and Passed.

This motion is seconded by COUNCILMAN ANNALDO.

COUNCILMAN O'CONNOR moves the Resolution be Amended in Paragraph 3, last line, following the word "funds" delete the period, add a comma, and insert the following: "subject to the following specifications and limitations;

"That no monies of the so-called "CD Float" shall be loaned or expended or in any way disbursed, without specified authorization of the City Council, and is hereby a condition of the authorization of submission of this application within the meaning of section (B) of the attached certification".

This motion being seconded by COUNCILMAN EASTON is Put to Vote and Not Passed by the following Roll Call Vote:

COUNCIL PRESIDENT PAOLINO relinquishes the Chair to COUNCIL PRESIDENT PRO TEMPORE STRAVATO in order that he may speak on the subject matter.

COUNCILMAN O'CONNOR moves that the Resolution be Amended by inserting in Paragraph 3, last line, following the word "funds", the period be deleted, a comma added and the following inserted; "subject to the following specifications and limitations;

"That the Mayor's Office of Community Development and the Providence Redevelopment Agency, jointly prepare Programs for Loans and Grants, for the West End Community."

This motion being seconded by COUNCILMAN EASTON is Put to Vote and Not Passed by the following Roll Call Vote:
