AMENDING CHAPTER 776 BY APPROPRIATING

THIRTY FIVE THOUSAND (\$35,000) DOLLARS TO AN ACCOUNT TO BE KNOWN AS  
"FORESTRY, SHOP AND STORAGE BUILDING ACCOUNT ", ITEM 6.

*Approved* November 20, 1953

*Be it ordained by the City of Providence:*

SECTION 1: Chapter 776 of the Ordinances of the City of Providence as approved September 18, 1953, and entitled: "An Ordinance Making Appropriation of \$29,679,752.90 for the Support of the City Government for the Fiscal Year Ending September 30, 1954", is hereby amended by appropriating the sum of Thirty Five Thousand (\$35,000) Dollars to an account to be known as "FORESTRY, SHOP AND STORAGE BUILDING ACCOUNT", ITEM 6.

SECTION 2: The said sum of Thirty Five Thousand (\$35,000) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3: The Estimated Receipts from Reserve for Extraordinary Expenditures are hereby increased by Thirty Five Thousand (\$35,000) Dollars.

SECTION 4: The City Controller and the City Treasurer are hereby authorized and directed to pay over this appropriation to an account in the Trust and Special Funds entitled: "Forestry, Shops and Storage Building Account". Any unexpended balance remaining in this account shall revert to the General Fund.

SECTION 5: This Ordinance shall take effect upon its passage.

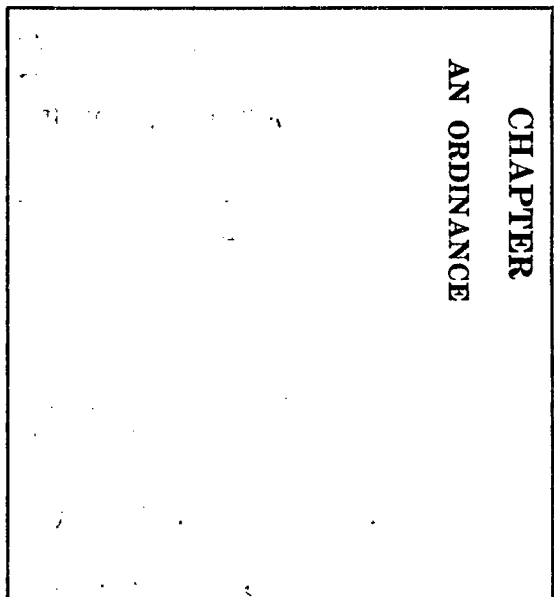

AMENDING CHAPTER 776 BY APPROPRIATING

ONE THOUSAND (\$1,000) DOLLARS TO AN ACCOUNT TO BE KNOWN AS "SUGGESTION AWARDS ACCOUNT", ITEM 3.

*Approved* November 20, 1953

*Be it ordained by the City of Providence:*

SECTION 1: Chapter 776 of the Ordinances of the City of Providence as approved September 18, 1953, and entitled: "An Ordinance Making Appropriation of \$29,679,752.90 for the Support of the City Government for the Fiscal Year Ending September 30, 1954", is hereby amended by appropriating the sum of One Thousand (\$1,000) Dollars to an Account to be known as SUGGESTION AWARDS ACCOUNT, ITEM 3.

SECTION 2: The said sum of One Thousand (\$1,000) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3: The Estimated Receipts from Reserve for Extraordinary Expenditures are hereby increased by One Thousand (\$1,000) Dollars.

SECTION 4: The City Controller and the City Treasurer are hereby authorized and directed to pay over this appropriation from the General Fund to an account in the Trust and Special Funds to be known as "SUGGESTION AWARDS ACCOUNT". Any unexpended balance remaining in this account shall revert to the General Fund.

SECTION 5: This Ordinance shall take effect upon its passage.

are hereby increased by Two Hundred Thousand (\$200,000) Dollars.

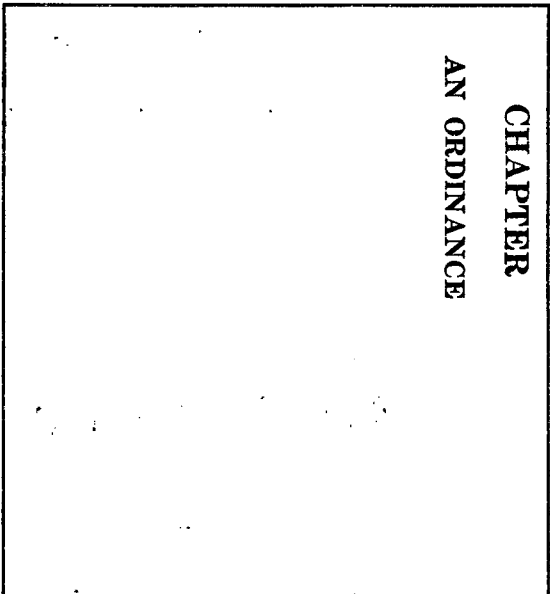
