Be it ordained by the City of Providence:

SECTION 1. Chapter 9 of the Code of Ordinances of the City of Providence entitled: "Fire Prevention and Protection," is hereby amended to read as follows:

ARTICLE III. CHARGES FOR EMERGENCY MEDICAL SERVICES. Section 9-37 Fees.

Each person receiving emergency medical services in the City of Providence shall be billed for the following fees, if applicable:

1. Advanced Life Support "ALS"	\$375 one way
2. Base Life Support "BLS"	325 one way
3. Cardiac Monitoring	50
4. Defibrillation	275
5. Airways	250
6. I.V.	75
7. Mast Trousers	75
8. Oxygen	90 per bottle
9. Mileage ALS	8.00 per mile
10. Mileage BLS	8.00 per mile
11. CPR	300
12. Medication Administration	35
13. Rhythm EKG/without interruption & RE	50
14. Miscellaneous Supplies	varies
