Gentlemen:

The Traffic Engineering Department has completed the investigation requested by City Council Resolution for "appropriate vehicular traffic control at the intersections of Canonchet and Waller Streets and at Waller and Manomet Streets."

Peak hour volume counts made at each location on June 3, 1965, indicate a volume of 29 vehicles on Manomet Street and 30 vehicles on Waller Street approaching the intersection during one hour. This is an average of one vehicle per minute entering the intersection. This is a minor volume when one considers that many of the intersections in the City have several hundred vehicles per hour.

A complete study of reported accidents at the intersection of Canonchet Street and Waller Street revealed one accident dated January 28, 1964; three accidents in 1961; and three accidents from 1951 to 1961 for a total of seven accidents in 15 years. The intersection of Manomet Street and Waller Street likewise has had ten reported accidents in the 15-year period. At this intersection there were no accidents reported between September of 1963 and March of 1965.

Because of the minor nature of traffic at these intersections, no warrants exist for "Stop" control at this time. I feel however that a speeding problem may exist on Waller Street, and a copy of this letter will be forwarded to Commissioner Goldstein for further action.
