**Summary of Providence Water's New
Restricted Fund Budgets
for Fiscal Year End 2008**

Property Tax Refund

This new fund was established by PUC order in Dk. 3832, as a result of the \$1.5 million Cranston Tax refund settlement Providence Water received in August 2007. The monies from this fund will reimburse the Operating fund \$375,000 per year, for the next 3 years beginning June 2008. The fund can also be used for tax litigation expenses including legal fees, appraisal fees and engineering analysis. Any unspent funds will be invested with the interest accruing to the Property Tax Refund account.

Highlights include \$1.5 million of property tax refund, \$.037 reimbursement to operating and an estimated \$.03 for services.

Revenue Reserve

This new fund was established by PUC order in Dk. 3832. The purpose of this fund is to provide a reserve for revenue shortfalls, especially in years of low consumption. The reserve is calculated at 2% of operating expenses less miscellaneous income, and is funded monthly. Providence Water will need to request use of these funds from the PUC prior to usage.

Highlights include \$.05 million in new revenue.
