RESOLUTION OF THE CITY COUNCIL

No. 191

Approved March 13, 1986

RESOLVED, DECREED AND ORDERED:

That the following named Street shown as cross-hatched area on the accompanying plan entitled, "Providence, RI Department of Public Works - Engineering Office, Street Line Section Plan No. 064338, dated December 12, 1985",

VIZ:

Thornton Street (portion of), shown as cross-hatched area on accompanying plan and designated by the letters (A-B-C-D-A) having ceased to be useful to the public and is proposed to be abandoned as a Public Highway, provided that the Providence Gas Company be granted a utility easement and be allowed access to their gas main for maintenance purposes; that petitioners and other adjoining property owners will convey an easement acceptable to The Narragansett Electric Company which will permit the retention of their facilities in existing locations in said Thornton Street, together with the right to inspect, maintain, operate and replace the same; New England Telephone and Telegraph Company be granted an easement acceptable to New England Telephone, which will permit retention of its facilities in existing locations with the right to inspect, maintain, operate and replace the same and with twenty-four hour access to said facilities and if the facilities are to be relocated the petitioner shall assume all costs; and the damage to the abutters is appraised at nothing and so awarded, and it is further

ORDERED, That the Director of Public Works be and he is hereby directed to cause a sign to be placed on the above-named highway abandoned as aforesaid, having thereon the words, "Not a Public Highway", and it is further

ORDERED, That after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper, published in the County of Providence at least once a week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the above-named highway which has been abandoned, who is known to reside within the State.

Gentlemen:

The City Plan Commission at its January 7, 1986 regular monthly meeting reviewed and evaluated the subject referral from your Committee.

The petitioners are: Ronald R. Silva of 107 Springfield Street - owner of abutting Lot 305 on A.P. 115, John W. O'Brien of 50 Ophelia Street - owner of abutting Lot 348 on A.P. 115 and Russell R. Vinacco of 20 Methyll Street, Providence, R.I. - owner of abutting lot 347 on A.P. 115.

A field inspection revealed that the subject portion of Thornton Street is an unpaved public right-of-way serving as a crossover between Springfield and Ophelia Streets. Large potholes with standing water and accumulation of debris on both sides of this crossover indicate lack of maintenance of this portion of Thornton Street by the City. A sign "Not a Public Thoroughway" located on the corner of Ophelia and Thornton Streets is reinforcing a status of abandonment.

More than a year ago, a similar petition pertaining to the portion of Thornton Street located between Eliza and Ophelia Streets was recommended by the City Plan Commission to be denied (see attached copy of CPC Referral No. 2134). However, the City Council approved the aforesaid abandonment on February 14, 1985.

A current field inspection revealed that aforesaid portion of Thornton Street located between Ophelia and Eliza Streets was abandoned and a chain link fence with gates was constructed on both ends of that portion of Thornton Street.



There is an indication of potential new residential development on the western side of Springfield Street (land is being offered for sale). The entire area located between Hartford Avenue, Killingly and Eliza Streets requires a comprehensive land development plan. An abandonment of existing public right-of-ways within the area without such a plan creates serious planning problems in the future as well as public safety hazards. The proposed abandonment of portion of Thornton Street between Ophelia and Springfield Streets does not meet the City Plan Commission's criteria for street, highway and right-of-way abandonment and therefore,

The Commission voted:

To advise the Committee on Public Works that this petition should be denied and that the Committee should seek advice from both the Police and Fire Departments on this matter.

Gentlemen:

The City Plan Commission, at its September 5, 1984 regular monthly meeting, reviewed and evaluated the subject referral from your Committee.

The petition was submitted by the owners of abutting lots 421, 371, 372 and 420 on AP 115. John B. Auger, Jr., Isabella and Joseph Sukaskas, Walker H. Berndt, Margaret and Thomas E. Mooney.

The Commission comments and recommendations are as follows:

A field inspection revealed that the subject portion of Thornton St. is a paved public right-of-way without sidewalks.

The owners of Lot 420, Mr. Thomas E. Mooney and his wife, are utilizing a portion of Thornton St. by extending their landscaped grounds approximately 16 feet into public right-of-way. They maintain double access driveways from Thornton St. and Eliza St.

The paved portion of the subject right-of-way is located close to the property lines of Lots 421 and 371 (approximately 1-2 feet).

Ophelia, Eliza and Springfield Streets are dead-end streets with no possibility of extending Eliza and Ophelia Streets because of a steep drop of terrain (over 20 ft.). Eliza Street, with a total length of 831 feet, would have only access from Hartford Avenue if the proposed abandonment of Thornton St. would take place.

From a planning point of view and from the point of public safety, it is important to maintain crossover access between Ophelia and Eliza Streets and therefore:

The Commission voted: to recommend to the Committee on Public Works that this petition be denied.

Enclosed is a map showing the street in question colored in red, and the nearest Department of Public Parks facility colored in green.

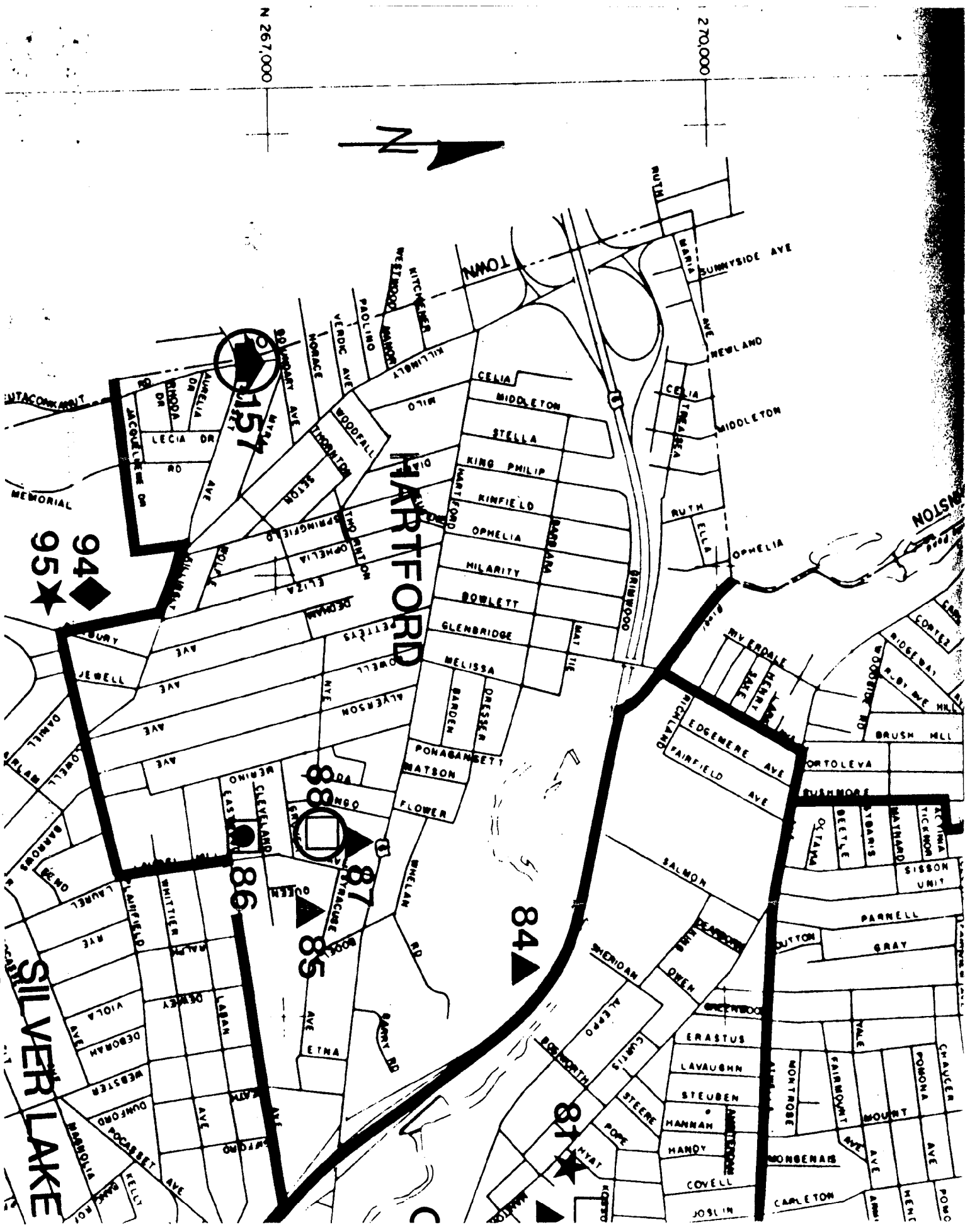


