REPORTS FROM COMMITTEES

COUNCILMAN DAVID V. IGLIOZZI, Chairman COMMITTEE ON ORDINANCES

Transmits the following with Recommendation the Same be Adopted, as Amended:

Resolution Requesting that Smoking be prohibited in Providence City Hall.

Whereas, The State of Rhode Island has identified "smoking tobacco in any form (as) a public nuisance and dangerous to public health" pursuant to Chapter 23-20.7.1-7 of the Rhode Island General Laws, and

Whereas, In the United States, 50 million smokers annually smoke approximately 600 billion cigarettes, 4 billion cigars and the equivalent of 11 billion pipefuls of tobacco, according to the U.S. Environmental Protection Agency, and

Whereas, Three major bodies were independently convened to consider the public health implications of passive smoking. Commission by

the U.S. Public Health Service under the Surgeon General, by the National Research Council (NRC) at the request of EPA, and by the congressionally-mandated Interagency task force on Environmental Cancer, Heart and Lung Disease, and

Whereas, The three separate bodies arrived at a consensus, that passive smoking significantly increases that risk of lung cancer in adults, and

Whereas, Surgeon General C. Everett Koop stated that a substantial number of the lung cancer deaths that occur among non-smokers can be attributed to involuntary smoking, and

Therefore, Be It Resolved, That the Providence City Council determines that smoking is a threat to the health of city workers, city residents and all visitors to city offices, and

Let It Be Further Resolved, That the City Council urges the Mayor, the Director of Administration and the Director of Public Property to take the necessary steps to ban public smoking from all city offices except in designated smoking areas which include ventilation systems that will exhaust the smoke directly to the outside, provide at least 60 cubic feet per minute of outdoor air per smoker; and provide negative pressure to prevent backstreaming of smoke into non-smoking areas,

Let It Be Further Resolved, That designated smoking lounges will be provided with signs, non-combustible ashtrays and receptacles for smoking materials, suitable signs indicating that smoking is prohibited except in designated smoking lounges must be provided at or near entrances

to facilities occupied and controlled by the City of Providence.

Let It Be Further Resolved, That smoking areas may not be designated in the following locations: office space, conference rooms, elevators, corridors, hallways, stairwells, the City Council Chambers, cafeterias or restrooms.

PERSONAL PRIVILEGE

COUNCILMAN CLARKIN Requests and is Granted the Floor to Speak on a Point of Personal Privilege:

About a year ago we abandoned Garnet Street. Garnet Street is a small street near the old Outlet Building. At the time that we abandoned it, Johnson & Wales was going to buy the Outlet Complex and build a dorm. At the time of the abandonment, I took a lot of heat as some downtown business owners did not want us to close the street. At that time, believing that what was proposed for the Outlet site was good for the City, I voted for the abandonment. A few months later, Johnson & Wales made known that they were not going to build the proposed dorm. I

approached the City Planner, Tom Moses, and was told by him that the deal did not go through and that the Street was not abandoned. Now I find out differently, we have abandoned the street. Two days after our original vote to abandon the street, I was going up Richmond Street and at the corner of Pine and Richmond Street, a moving truck was unloading into the Ocean State Theater. Pine Street was closed off for half a day. The detours around in order to get to the center of the City are bad. Garnet Street is a needed street. My vote to close the street was a mistake and I want to do whatever is necessary to reopen Garnet Street. I was a new Councilman at the original vote. I took people at their word that it was not abandoned when the sale of the Outlet

fell through. I am not so new now. I will do whatever I have to do to reopen the street. I have spoken to Johnson & Wales lawyers and they have

been responsive to me. I need your help to reopen Garnet Street.
