SECTION 1. Section 20 of Chapter 68-57 of the Ordinances of the City of Providence, approved September 23, 1968, as amended, is hereby further amended as follows:

SECTION 20: FIRE DEPARTMENT

That part which has heretofore read: "The number of employees in the Fire Department shall not exceed five hundred fifty six (556)"; shall hereafter read: "The number of employees in the Fire Department shall not exceed five hundred fifty seven (557)".

SECTION 2. This Ordinance shall take effect upon its passage.





Approved April 4, 1969

RESOLVED, That His Honor the Mayor be and he hereby is authorized to execute a deed of the following parcel of real estate presently held by the City of Providence, under trust created by the Will of the late Charles H. Smith, to FRANCIS P. DAVIS for such sum of money as hereinafter stated; such sale authorized by a resolution adopted by the Commissioners of the Estate of Charles H. Smith, approved August 26, 1968.

Said parcel to be sold to FRANCIS P. DAVIS for the sum of ONE HUNDRED THIRTY-FIVE THOUSAND (\$135,000) DOLLARS.

That certain lot or parcel of land, with all buildings and improvements thereon, situated at the northeasterly corner of Moulton Street and Westminster Street, in the City and County of Providence and State of Rhode Island, bounded and described as follows:

Beginning at a point in the northwesterly line of Westminster Street, said point being the southwesterly corner of land now or lately of Anthony C. Paolino and the southeasterly corner of the premises herein described; thence running northwesterly, bounding northeasterly on said Paolino land in part and in part on land now or lately of Anthony C. Paolino Inc. and land now or lately of Joseph P. 



# RESOLUTION OF THE CITY COUNCIL

No. 197

Approved April 4, 1969

WHEREAS, April 22, 1969, is the Five Hundred and Eighteenth Anniversary of the birth of Queen Isabella, of Castile, Spain, daughter of Juan the Second, ruler of Castile, Spain, and wife of Ferdinand of Oregon with whom she reigned as Queen of Castile and Lyon, and

WHEREAS, the Daughters of Isabella, founded in the State of Connecticut in 1896 for the purpose of uniting all Roman Catholic women into a fraternal and beneficial society of mutual friendship and to establish a bond of unity in truth and in interest in times of trouble and disasters, and

WHEREAS, as Queen, Isabella who, at the age of twenty-three became the reigning monarch of her beloved Spain and, for seventeen years, was one of the most influential women of her time who exerted a stabilizing influence over her kingdom, was a model of virtue, piety and domestic economy, although she suffered from numerous personal tragedies, and

WHEREAS, her foresightedness and vision, far beyond the immediate realities of her time linked her name in history with the discovery of the New World by the Italian Navigator Christopher Columbus,

NOW THEREFORE BE IT RESOLVED, That His Honor Mayor Joseph A. Doorley, Jr., and the members of the City Council hereby to proclaim April 22, 1969, as "Queen Isabella Day" in memory of and in honor of Queen Isabella of Castile, Spain, founder of the Daughters of Isabella.
