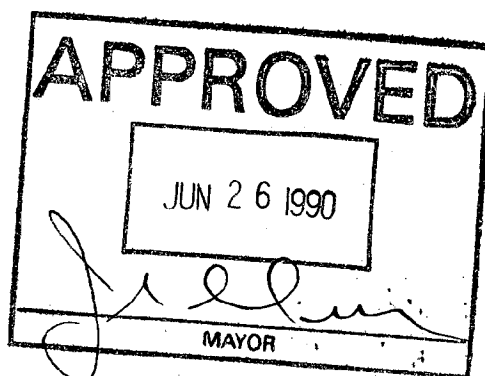

1        SECTION 1. The city of Providence shall be exempt from giving  
2        the notice to persons and the manner required by the second paragraph  
3        of section 45-24-4 of the general laws of 1956, as amended, with  
4        respect to any comprehensive amendment to its existing zoning ordi-  
5        nance introduced by any member of the city council during the years  
6        1990-91.

7        SECTION 2. This act shall take effect upon passage.

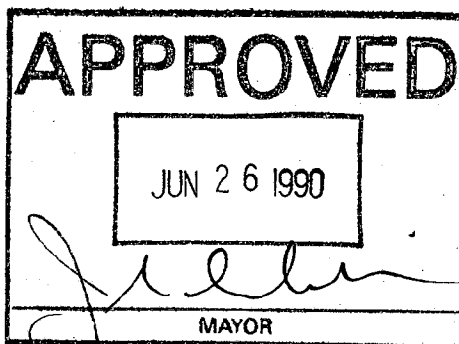

It is enacted by the General Assembly as follows:

- 1 SECTION 1. Section 45-24.1-10 of the General Laws in Chapter
- 2 45-24.1 entitled "Historical Area Zoning" is hereby amended to read as
- 3 follows:
- 4 45-24.1-10. Enforcement. -- Any duly authorized local official
- 5 or any local building official may bring an action against any prop-
- 6 erty owner who fails to comply with the requirements of section
- 7 45-24.1-4. Such actions shall be brought in the municipal housing
- 8 court having jurisdiction where the violation occurred or is likely to
- 9 occur or if no municipal housing court is in existence, then in the
- 10 superior court having jurisdiction where the violation occurred or is
- 11 likely to occur. Plaintiffs may seek restraining orders and injunc-
- 12 tive relief to restrain and enjoin violations or threatened violations
- 13 of this chapter.
- 14 SECTION 2. This act shall take effect upon passage.
