Cianci, Jr., Mayor of the City of Providence, has, pursuant to Sections 406 and 803 of the Providence Home Rule Charter of 1980, requested the City Clerk, in writing, to Call a Special Meeting of the City Council to be held on the 2nd day of May, A.D., 1997, at 12:30 o'clock for the purpose of Enacting the following:

Budget Message and appropriation Ordinance setting forth in detail estimates for the fiscal period beginning July 1, 1998 and ending June 30, 1999.

HEROF, Fail Not, and make a true return of this Warrant, with your doings thereon.


