RESOLUTION OF THE CITY COUNCIL

No. 174

Approved April 13, 1980

RESOLVED, That the City Solicitor is requested to prepare, cause to be introduced and to urge passage at the 1980 Session of the General Assembly of an Act to Increase the Pension Benefits for Class "B" Retired Employees as follows: Increases would be granted on a percentage basis according to the following categories, increases to be based on the gross monthly pension of Class "B" employees received in the month of March 1980 to be applied to all categories of Class "B" pensions.

0 - \$300.00	15%
\$300.01 - \$350.00	13%
\$350.01 - \$400.00	11%
\$400.01 - \$425.00	9%
\$425.01 - \$450.00	8%

\$475.01 - \$500.00	6%
