## **PERSONAL EXPRESSIONS**

**COUNCILMAN JACKSON Requests the privilege of the floor to speak on a Point of Personal Expression and states:**

I cannot sit here tonight without commenting on an article that appeared in Wednesday's Journal paper where the Mayor of Cranston, Stephen Laffey, lashed out at our most vulnerable population, our precious children of the City of Providence.

As we all know, it's that silly time of year where every politician is trying to show how they're delivering to their cities. It's just another ridiculous political move to blame the victim. When will all the lawmakers of the State and the leaders of the

State realize that it is their responsibility to educate, and I repeat, to educate, all of the children of the State of Rhode Island. A State as small as Rhode Island still cannot get it and realize the responsibility they have to give all our children a fair and equal education, and fair and equal at times means that you cut the pie in unequal slices and the people who need the most get the most. Not like today based on politics but based on a system that accounts for your ESL population, your Special Needs population and the level of poverty our children live in. Must I remind everyone we have the fourth highest percent in the United States of America tied with New Orleans and we see how well the government is taking care of the people who lived in poverty in New Orleans, they're just not taking care of them. All research will point to these factors as the biggest deterrence to leveling the field. Even Mayor Laffey himself knows this when he states the City of Cranston should be penalized by these needs in referring to the "No Child Left Behind Act". So he's even admitting that the act is unfair to the Providence School System because he does not want his city to be held accountable if the students from Providence go to his city, Cranston. There are four points that need to be made clear. One, Providence schools and the leaders and teachers have made clear progress for our children. There are numerous innovative programs operating today in our schools. Mr. President, yourself, myself and the Honorable President Pro-Tempore was just a few weeks ago at a program at Hope High School to again show

what the leaders are doing in the City of Providence to make our schools the best. This Honorable body itself has made hard choices and raised taxes specifically to keep education on the right track. The State Department of Education continues to praise the progress that the City of Providence School Department has made and our children have made. Now, point two, there finally needs to be a fair and equitable system from the State to provide an equal education for all, yes all children in the State. This in effect would reduce every city relying on property taxes. This would also stop the politicking that we all take part in every year to get more money for our systems. This Statewide funding would be beneficial to all cities. Stop blaming the children for a system that will not fund them equitably. Third, the "No Child Left Behind Act" should not be driving educational philosophy, and four, it's easy to pick on the most vulnerable because the normally don't have a voice. It is about time we stand up to politicians that wanted to throw stones on them to gain favor and to try to drive a bigger wedge between the have and the have not's. Instead, they should fight to create a system equitable, for a system that has been un-equal for far too long. Finally, a question to be raised. How many students have or are still attending Classical who did not or still do not live in the City of Providence? It is time we all took responsibility for all our children in the State of Rhode Island, stop fighting between ourselves but stay united for the benefit of our children. Thank you Mr. President.
