Status Report

DATE : April 3, 1979

On December 26, 1978 the Board of Contract and Supply awarded the contract for the above project to the Coken Company, Inc. subject to the approval by the City Council of the West Broadway Plan Amendment.

Subsequently the Council approved the amendment and an Agreement was executed between the Coken Company and the Agency on January 9, 1979. On January 18, 1979 a letter was forwarded to the Coken Company with a Notice to Proceed with construction on February 5, 1979.

Unusual problems and delays were encountered in processing shop drawings for approval. Approved shop drawings were eventually submitted to the contractor on March 16, 1979. The Coken Company has since notified us that delivery of materials will take from six (6) to eight (8) weeks and on receipt of the materials construction will begin.

It would appear at this time, that with no further delays, the project should be completed on or about June 15, 1979.
