Approved August 18, 1989

RESOLVED, that His Honor, the Mayor, is hereby authorized to execute a Lease of Lot 136 on City Assessor's Plat 55, located along Allens Avenue, said lot to be leased to Steven Broomfield, d/b/a Broomfield and Sons, of Providence, Rhode Island for the sum of Twelve Thousand Seven Hundred Ninety-Two and 51/100 (\$12,792.51) Dollars per year for a five (5) year period, with option to renew for an additional five (5) years with rental to be renegotiated at that time and with such other terms and conditions as have been imposed by the Committee on City Property, the City Council, the City Solicitor and His Honor, the Mayor.




