

# **RESOLUTION OF THE CITY COUNCIL**

**No. 434**

***Approved August 1, 2011***

WHEREAS, Bruce Sundlun was born in Providence on January 19, 1920 to Jewish immigrants from Lithuania; and

WHEREAS, He attended Providence public schools, graduating from Classical High School in 1938; and

WHEREAS, In 1941, he volunteered for the United States Army Air Forces, flying B-17 bombers during World War II; and

WHEREAS, After his plane was shot down over Nazi-occupied Belgium, Sundlun avoided capture and joined the Maquis, a rural guerrilla arm of the French resistance; and

WHEREAS, He earned the rank of Captain, a Purple Heart, , the Distinguished Flying Cross, the Air Medal, and was named a Chevalier of the French Legion of Honor during his service; and

WHEREAS, After the war, he returned to the U.S. to complete his undergraduate education at Williams College and, in 1949, earned a law degree from Harvard University; and

WHEREAS, He was a successful businessman, managing law firms in Providence and Washington, D.C., serving as the president of Executive Jet Aviation, CEO of The Outlet Company, and was a founding member of The Communications Satellite Corporation (COMSAT); and

WHEREAS, In 1979, he was awarded the Prime Minister's Medal by the State of Israel for his important role in helping to form the Israeli Air Force; and

WHEREAS, He was involved with and held leadership positions with numerous community and philanthropic organizations, including serving as the president of Temple Beth-El in Providence; and

WHEREAS, A true believer in public service, Sundlun was a member of Providence School Board, was director of the National Security Education Board, served on the Board of Visitors of the U.S. Air Force Academy, was an Assistant U.S. Attorney, a Special Assistant to the U.S. Attorney General, and was selected as a delegate to the Democratic National Convention five times; and

WHEREAS, In 1990, he was elected Governor of Rhode Island with 74% of the vote, the largest majority in the state's history, and was re-elected in 1992; and

WHEREAS, During his four years in office, Governor Sundlun was instrumental in helping Rhode Island recover from major banking and financial crises; and

WHEREAS, He helped make our state a greater tourist destination through the establishment of the Rhode Island Convention Center, the Rhode Island Airport Corporation, the Quonset Air Museum, and the expansion of T.F. Green Airport; and

WHEREAS, All Rhode Islanders owe Governor Sundlun a debt of gratitude for his service to the state and his dedication to the greater good; and

WHEREAS, Governor Bruce Sundlun passed away on Thursday, July 21<sup>st</sup>, 2011.

BE IT FURTHER RESOLVED, That the City Council of the City of Providence extends its deepest condolences to the entire Sundlun family.


