AN ORDINANCE AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1984-53 APPROVED JULY 20, 1984, BY TRANSFERRING THE SUM OF FIVE THOUSAND DOLLARS (\$5,000.00) FROM GROUNDS MAINTENANCE (1-007-02-199) TO GROUNDS MAINTENANCE (1-007-02-571).

Be it ordained by the City of Providence:

SECTION 1. Chapter 1984-53 of the Ordinances of the City of Providence, as approved July 20, 1984, entitled: "An Ordinance making an Appropriation of One Hundred Seventy-One Million, Fifty Six Thousand, One Hundred Seventy Seven Dollars and Fifty Seven Cents. (\$171,056,177.57) for the fiscal year ending June 30, 1985, as amended", is hereby further amended by transferring the sum of Five Thousand Dollars (\$5,000.00) from Grounds Maintenance (1-007-02-199) to Grounds Maintenance (1-007-02-571).

Section 2. This Ordinance shall take effect upon its passage.

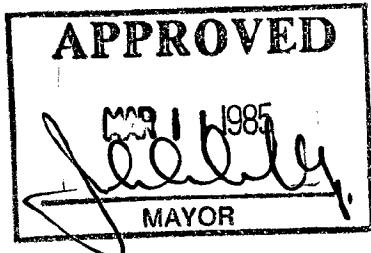
