Dept.-Engineering Office, City Property Section, Plan No. 061750, Date August 5, 1958", has ceased to be useful to the public and the same is abandoned as a public highway and the damage to the abutters is appraised at nothing and so awarded, and it is further

ORDERED, that the Superintendent of Street Signs and Numbers be and he is hereby directed to cause a sign to be placed on part of Claverick Street from Clifford Street northwesterly to its termination, abandoned as aforesaid, having thereon the words, "Not a Public Highway", and it is further

ORDERED, that after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper published in the County of Providence, at least once each week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting upon part of Claverick Street from Clifford Street northwesterly to its termination, which has been abandoned, who is known to reside with in this State.

This referral is a request for the abandonment of a portion of Claverick Street from Clifford Street to the condemnation line, roughly 95.45 feet, to the North-South Freeway.


On the field trip it was found that the street in question is paved.


The portion of Claverick Street proposed for abandonment extends from Clifford Street northwesterly approximately 95 feet to the North-South Freeway and is 40.12 feet in width.

The State of Rhode Island and the Claverick Realty Company would each acquire one-half of the area, if the proposed abandonment is approved.

This portion of Claverick Street is no longer of value as a public highway, but eight public curb parking spaces will be eliminated with the abandonment.


However, the North-South Freeway is to be extended southerly from a point adjacent to the portion of the street proposed for abandonment and there is a possibility that the use of the street would be of advantage during construction.




