ORDERED, That the Superintendent of Street Signs and Numbers be and he is hereby directed to cause a sign to be placed on the portion of Carvel Street from Brush Hill Road to Hillcrest Avenue, abandoned as aforesaid, having thereon the words, "Not a Public Highway", and it is further

ORDERED, That after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper published in the County of Providence, at least once each week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the portion of Carvel Street from Brush Hill Road to Hillcrest Avenue which has been abandoned, who is known to reside within this State and it is further

ORDERED, That Resolution No. 492, approved September 21, 1961, decreeing and ordering that Carvel Street from Brush Hill Road to Hillcrest Avenue be abandoned as a public highway is hereby rescinded.




