

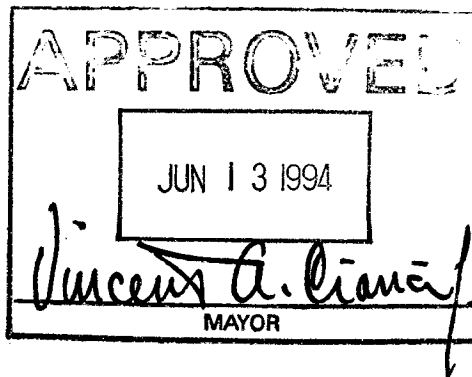

94 - S 3039 *as amended*

It is enacted by the General Assembly as follows:

1 SECTION 1. Chapter 45-24 of the General Laws entitled  
2 "Zoning Ordinances" is hereby amended by adding the  
3 following section thereto:  
4 45-24-55. Meaningful hearing for location of  
5 community residences. -- While the requirements pertaining  
6 to local zoning are waived for community residences as  
7 defined in section 45-24-31 (15) herein, no community  
8 residence shall be established or expanded without a  
9 ~~meaningful~~ hearing being held in the neighborhood where the  
10 residence is located or is to be located. Adequate public  
11 notice shall be given for this hearing and opportunity  
12 shall be allowed at the meeting for public discussion and  
13 comment. Decisionmakers of the agency or department who  
14 have made the final decision to place the residence in the  
15 neighborhood and who designed the
