Whereas, this coveted rating may save the City in excess of Seven Hundred Thousand Dollars in bond sales, in the amount of Forty-four Million. Two Hundred Thousand Dollars, in its proposed Six-Year Capital Improvement Program, and

Whereas, the decision rendered by the Moody's rating was motivated by the City's well-planned debt structure and anticipated trend of future financing under a well-designed capital improvement program; favorable factors which include the City's sound operating record, over an extended period of time; precedent

financial management and realistic budgetary practices demonstrated by an awareness of the City's fiscal capabilities,

Now Therefore, Be It Resolved, that in recognition of this most favorable Aa Bond Credit Rating, this City Council is not unmindful of the budgetary vigilance practiced by His Honor, Mayor Joseph A. Doorley, Jr., and of the sound, fiscal management and expertise rendered by Director of Finance, Vincent T. Izzo, who, during their respective tenures of office, have received many accolades for their management in leading the City of Providence to this most creditable financial status.

*Whereas*, the problem of increasing lawlessness especially among juveniles and the category of sex crimes is a nationwide problem, which is also affecting our community; and

*Whereas*, prevention and instruction in prevention has been formulated and emphasized for many years in fire control work; and

*Whereas*, until recently police work has been concentrated on enforcement; and

*Whereas*, the City of Providence spends millions of dollars to support education, and the area of crime among our youth has become so substantial that, were it possible to emphasize respect for authority and the virtues of honesty, courtesy, patience and consideration of others as part of school curriculum, just as the teaching of fire prevention and health education has been very salutary, so might knowledge by the public of crime control, and it is desirable police personnel be more in touch with the public;

*Now, Therefore, Be It Resolved*, that the Commissioner of Public Safety communicate with the school authorities to prepare a program

whereby selected members of their department speak before assemblies of clubs, organized groups, and schools in the area so that the public have the opportunity to learn crime prevention and methods for reducing crime.
