"I would just like all of us to pause for a moment as we gather for our first meeting back from what was a very busy break with community events to focus on our mission here together. **COUNCIL PRESIDENT MILLER, COUNCILMAN ESPINAL,

Resolution Authorizing the Mayor to sign a waiver and tax treaty with Trinity Repertory Theatre of Rhode Island on behalf of the City.

WHEREAS, The Foundation for Repertory Theatre of Rhode Island, Inc. merged into the Trinity Repertory Company (“Trinity Rep”) as of June 30, 1995; and

WHEREAS, Trinity Rep, as successor by merger to the Foundation for Repertory Theatre of Rhode Island, Inc., owns the Lederer Theater Center at 201 Washington Street in the City of Providence (also known as Assessor’s Plat 25 Lot 186) (the “Property”); and

WHEREAS, Trinity Rep is exempt from paying municipal property taxes on the Property by virtue of “An Act Providing for Exemption from State and Local Taxes for the Property Owned by the Foundation for Repertory Theatre of Rhode Island, Inc.,” passed by the General Assembly as 79-H 6156 on May 5, 1979 (the “Tax Exemption Act”); and

WHEREAS, By virtue of the Tax Exemption Act, the Property has historically been exempt from paying municipal property taxes pursuant to R.I. Gen. Laws § 44-3-3(a)(10); and

WHEREAS, R.I. Gen. Laws § 44-3-3(a)(10) provides that any such tax exemption is effective, “unless the exemption has been waived in whole or in part;” and

WHEREAS, Trinity Rep is willing to waive the tax exemption by agreement to allow the Property to be on the tax rolls for a period to include either a Phased Project, or following the date that the Rhode Island Historical Preservation & Heritage Commission issues a Certificate of Completed Work, whichever is longer (the “Tax Roll Period”); and

WHEREAS, The City of Providence (the “City”) and Trinity Rep will agree that the Property will not be considered tax exempt pursuant to R.I. Gen. Laws § 44-3-3(a)(10) for the Tax Roll Period, and that the amount of property taxes to be paid shall be ten thousand dollars (\$10,000) annually during the Tax Roll Period, irrespective of Property assessment and rate of tax (the “Annual Tax Payment”); and

WHEREAS, The Annual Tax Payment is due and payable in the same manner as property taxes, and the bills and payments will be subject to Chapters 3, 5, and 9 of Title 44 of the Rhode Island General Laws.

NOW, THEREFORE, BE IT RESOLVED:

Section 1. Exemption. That upon the execution of a waiver and tax treaty between Trinity Rep and the City of Providence, as described generally above, the Property will not be considered tax exempt under R.I. Gen. Laws § 44-3-3(a)(10), and will be subject to taxation as described above and outlined in the waiver and tax treaty.

Section 2. Authority. The Mayor of the City has the authority to sign a waiver and tax treaty with Trinity Rep on behalf of the City.

COUNCILWOMAN PETERSON Requests the privilege of the floor to speak on a Point of Personal Expression and states:

“I would like to take a minute in regards to number 23. I would like to take a moment just to acknowledge the wonderful people that are here in support of the nice words that we are going to say honoring the life and legacy of James Wilson. Today, we come together to remember and celebrate the life of James Eric Wilson who made a profound impact on the lives of countless boys and girls of various ages around the City of Providence. We gather to honor a youth coach who dedicated their time, passion, and wisdom to shaping not only great athletes but outstanding individuals. James was also an amazing father, husband, and pillar of his community as shown by the outpouring of love and support to his family after his passing.

James was a youth coach in football, bowling, and baseball for the better part of the last fifteen years. What does it mean to be a youth coach? Well, you have taken on the task of teaching them the two beautiful games of sport and life. When you are a youth coach you are connected to these young lives fully. You get mad for them, you get sad with them, you are happy when they are happy, and are excited when they are excited. You live to see them succeed and you are connected with them forever. As parents, we see these little extensions of ourselves having their passions ignited and their characters shaped by these formidable influences. I’m very thankful that both my children have been impacted by Coach Wilson’s love of Elmhurst Youth Baseball.

One of the most incredible aspects of youth coaching is the ability to mold young minds and help them discover their potential. Coach Wilson excelled in this role, nurturing not just talent, but character. He taught our children about teamwork, perseverance, and the importance of never giving up, both in sports and in life. For example, this past year he helped a child overcome his fear of the baseball by putting him at catcher where you could not avoid getting hit with the ball but you would have the feeling of being protected by the equipment. The smile on this player’s face as he succeeded was what it is all about.

James possessed a rare gift of patience and understanding. He knew that success on the field was important, but so was the development of the individual. He took the time to mentor and guide each player, instilling in them confidence and a sense of self-worth. He was a coach who believed in every child's potential, and he made sure every child believed in themselves.

As we reflect on Coach Wilson's legacy, we can see it in the countless young people who are in this room tonight. We see it in the bonds of friendship formed among teammates, the lessons of sportsmanship learned, and the dreams inspired. Coach Wilson was not just a coach but a role model who showed our children what it meant to be a person of character, integrity and compassion.

In closing, let us remember James Wilson not with sorrow, but with gratitude for the positive influence he had on our children and our community. He will forever hold a special place in our hearts, and their spirit will live on in the actions and achievements of the young athletes he coached. Thank you, James Eric Wilson for your unwavering dedication to our youth. Your legacy will continue to inspire us all. In true Coach Wilson fashion, I'd like to ask my young players and families here to please help me conclude these words the way only Coach Wilson ever could.

Resolution Establishing a Special Commission for Taxation and Revenue.

WHEREAS, Rhode Island General Law Chapter 44-5 governs the assessment and levy of local property taxes and also delineates the process and timelines by which municipalities may revalue taxable property; and

WHEREAS, Said Rhode Island General Law requires a municipality to perform a full physical revaluation every nine years and a statistical revaluation every three years; and

WHEREAS, Appropriate financial budgeting is dependent upon the accurate and timely valuation of property; and

WHEREAS, Consistent and dependable property revaluations are crucial to ensuring equitable and predictable assessment of local taxes, nonetheless the standards for revaluations and the levying of taxes vary broadly across municipalities; and

WHEREAS, Dramatic shifts in the real estate market over the past ten years have resulted in wide fluctuations in property valuations throughout the city and the impact of these fluctuations have burdened residential property owners and commercial businesses in an inequitable manner; and

WHEREAS, Reliance on property taxes for its primary source of revenue constrains the City's ability to invest and serve the future needs of its citizens; and

WHEREAS, A comprehensive review of state taxing enabling law, the City of Providence's taxing and levying structure across all revenue streams, and a robust review of national best practices is necessary to develop a more equitable tax structure for the people of Providence.

NOW, THEREFORE, BE IT RESOLVED,

- (1) Creation. It is hereby declared that the public welfare and interest of the citizens of Providence will be best served by establishing a Special Commission for Taxation and Revenue.
 - (2) Composition. The commission shall consist of 9 members appointed by the Council President. The members shall represent a cross section of the community and possess substantial experience in areas that would be beneficial in carrying out the purposes of the commission. The proposed members will be the following:

 - Councilor Sue AnderBois
 - Councilman Pedro Espinal
 - Michael DiBiase
 - Lawrence J. Mancini, Chief Financial Officer
 - Tom Sgouros
 - Sharon Conard-Wells
 - Jane Driver
 - Robert I. Stolzman
 - (3) Charge to the Commission. (a.) The Commission shall conduct a comprehensive review of state taxing enabling law, the City of Providence's revenue streams from all sources, the City's taxing and levying structure, a robust review of national best practices as is necessary to develop a more equitable and fair tax structure for the people of Providence and to make recommendations regarding appropriate changes to City's tax policy and state law, including but not limited to, study and analysis of the overall revaluation process, commercial tax rate, residential tax rates, and exemptions. (b.) Further, the Commission shall consider alternative revenue streams that diversifies City revenue to reduce the burden on property owners. (c.) The Commission will issue a report of recommendations to the City Council within 120 days from the date of appointments with the intent of concluding its work by December 31, 2023.
 - (4) Purpose and Powers. The commission shall be embodied for the following purposes in order to further the public welfare: Taxation and Revenue. To carry out said purposes, the Commission shall have the power to: do all things, subject to limitations as may be imposed by state statute or city ordinance, necessary and convenient to carry out the purposes of the commission for the public welfare;
 - (5) Staffing. The City Council Chief of Staff, Tax Assessor, Auditor, Finance and Solicitor offices shall be responsible for providing resources and reports and assist the commission in carrying out its duties.
