


Gentlemen:

We have completed our investigation of traffic conditions at the intersection of Carleton St. and Roanoke St. which you requested.

Volume counts made at this location show low volumes of traffic on both of these streets. In addition, our accident records show only eight reported accidents at this location since January 1, 1959.

In view of these facts, we do not recommend the installation of Stop signs at this intersection.




