AN ORDINANCE AMENDING THE APPROPRIATION ORDINANCE, CHAPTER 1981-39, EFFECTIVE JULY 20, 1981, BY TRANSFERRING THE SUM OF TWO THOUSAND FIVE HUNDRED DOLLARS (\$2,500.00) FROM CONTINGENCIES ITEM 199 TO ARCHIVES AND HISTORY ITEM 199.

Be it ordained by the City of Providence:

SECTION 1. Chapter 1981-39 of the Ordinances of the City of Providence, effective July 20, 1981, Entitled: "An Ordinance Making an appropriation of One Hundred Forty Nine Million, Eight Hundred Sixty - Two Thousand, One Hundred Twenty-Two Dollars and Nine Cents (\$ 149,862,122.09) for the Fiscal Year Ended June 30, 1982", is hereby amended by transferring the sum of Two Thousand- Five Hundred Dollars (\$2,500.00) from Contingencies Item 199, to Archives and History Item 199.

SECTION 2. This Ordinance shall take effect upon its Passage.
