The purpose of this letter is to request your assistance in blocking off several areas around our culinary campus on Friday, October 12, 2001 and Saturday, October 13, 2001 in preparation for our annual Homecoming Parade. The areas requested are as follows:

Friday, October 12, 2001: Shipyard Street, just after the main parking lot entrance down to Harborside Boulevard, the entire right hand side needs to be made temporary no parking. The Parade Review Stand will be set up along this side of the street. The stand itself, once assembled, may stick out into the street slightly. If this is the case, appropriate safety equipment (i.e. barrels or saw horses) will be needed. I have been informed that the company setting up the review stand will arrive on scene at approximately 4:00pm.

Saturday, October 13, 2001: Harborside Boulevard at its intersection with Shipyard Street going completely across the Street. We will notify George Mann that this area will be blocked off.

We will also need to set up a barricade across Shipyard Street just before the Main entrance to keep local traffic from driving through the Parade route.

RE: HOMECOMING PARADE

I am in receipt of your letter concerning your Homecoming Parade on Saturday, October 13, 2001. Please be advised that you are required to contact Councilman Aponte so that he can pass a resolution authorizing this department to close the necessary streets. You can reach him through the City Council Office in City Hall (421-7740). This is just a legal formality, as well as informing the councilman of events occurring in his ward.

Due to the close proximity to the LPG tank, I have also forwarded a copy of your letter to Commissioner John Partington. He is now directing the Mayor's new Public Safety Task Force. The Task Force shall examine the points of vulnerability to terrorist attack with the City of Providence, and make recommendations for diminishing such vulnerability to the extent feasible. Areas of consideration should include municipal buildings; high-rise structures; places of assembly; transportation facilities, bridges and streets; utility buildings and plants; and facilities for the storage of hazardous, flammable, or explosive materials.
