



As is the custom, the members will meet with you relative to your appointment to the Housing Board of Review prior to transmitting their approval to the full City Council.

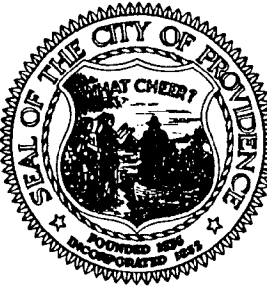
