That the following named person, firm or corporation is hereby granted permission to erect, alter or use a building or structure at the location named herein for the sale of petroleum, kerosene, gasoline, coal oil and their products, compounds and components as described and shown in and on the application therefor and accompanying plat, all on file in the Office of the Department of Building Inspection subject to the conditions that said person, firm or corporation shall not violate any of the laws of the State of Rhode Island or any of the Ordinances of the City of Providence relative to the erection, use or occupation of said structure and that said person, firm or corporation shall not allow petroleum, kerosene, gasoline, coal oil or their products, compounds or components, to be conveyed over or across any sidewalk by means of any pipe or hose, and upon such special conditions as are hereby enumerated and further provided that the Director of the Department of Building Inspection may authorize minor changes in the structural detail of plans on file, viz:

Ward 10. City of Providence, Richfield Oil Corporation, Lessee, Terminal Road, Plat 56, Lot 254; one (1) 15,000 barrel petroleum storage tank, additional making a total capacity of 437,389 barrels upon premises.

The erection or location of any buildings or structures not shown on the original plat on file with the Director of Department of Building Inspection, or any change in the location of buildings or structures from that shown on said plat shall be deemed a violation of this permit.


Subject: Installation of Storage Tank at Terminal Road

*The undersigned respectfully petitions your honorable body*

To erect a fireproof canopy on the present one story building (formerly the Washington and Raymond Buildings, so-called) located at 99 to 115 Washington Street and from 90 to 94 Mathewson Street.


Building is bounded by Washington, Mathewson and Clemence Streets on Plat No. 25 - Lots No. 157-158-159.

The canopy will consist of channel iron framing, steel decking on the top surface with a non-combustible material on the underside with adequate lighting. It will extend 6 feet from the property line. The sidewalk over which it will extend is 9 feet 4 inches in width thereby the overhang will be 3 feet 4 inches from the edge of the curb. The canopy clearance above the sidewalk will be 19 feet at the highest point away from the property line and 15 feet at the property line, which will be the lowest point.

# RESOLUTION OF THE CITY COUNCIL

No. 561

Approved September 24, 1963

Resolved,

That in accordance with the provisions of Section 28 of Chapter 1665 of the Public Laws of 1945, approved April 27, 1945, the City Controller is hereby authorized and directed to establish in the accounts for the year ending September 30, 1963, a specific purpose account to be known as "Reserve for Revenue for Extraordinary Expenditures of the year 1963-1964". Said account shall be established by charging to the account entitled "Current Year Surplus" of the accounts of 1962-1963, an amount equal to any credit balance existing in said Current Year Surplus Account at the close of the fiscal year. After completion of the above transfer, the account entitled "Reserve for Revenue for Extraordinary Expenditures of the Year 1963-1964" shall be carried over to the books of account for the year 1963-1964 with an open credit balance equal to the amount of the transfer.

From time to time during the year ending September 30, 1964, the City Council, when necessary, may direct the City Controller and the City Treasurer to pay out of General Fund cash the total or any part of the then credit balance existing in the account entitled "Reserve for Revenue for Extraordinary Expenditures of the Year 1963-1964", each such payment shall be charged to said account and shall immediately be paid over to the City Collector as a receipt account, and when so received by him, shall be credited to a receipt account to be entitled "Receipts for Extraordinary Expenditures of the Year 1963-1964". The City Controller and the City Treasurer are hereby authorized and directed to pay out of General Fund Cash, the total of any balance remaining in the "Reserve for Revenue for Extraordinary Expenditures of the Year 1962-1963" and such payment shall be charged to said account and paid over to the City Collector as a receipt; to "Receipts for Extraordinary Expenditures of the Year 1962-1963". The estimated "Receipts for Extraordinary Expenditures of the Year 1962-1963" are hereby increased by an amount that will make such estimate equal to the actual "Receipts for Extraordinary Expenditures of the Year 1962-1963".
