

RESOLUTION OF THE CITY COUNCIL



Approved August 8, 2014

RESOLVED, That as part of the I-195 Redevelopment Project, the Rhode Island Department of Transportation (RIDOT) has begun the process of physically reconnecting South Main Street and South Water Street on the former I-195 highway land (see map below).

Reconnecting these streets will result in street names changes south of Wickenden Street. In order to ensure continuity, it is requested that the following streets be renamed.

1. The existing portion of South Water Street between Wickenden Street and India Street shall be renamed BRIDGE STREET.
2. The existing portion of South Main Street between Wickenden Street and India Street shall be renamed SOUTH WATER STREET.
3. The existing portion of roadway starting at the northeast intersection of the proposed BRIDGE STREET shall be renamed WICKENDEN STREET.
