



RESUME

After a twelve year run as account executive at local radio and television outlets, Steve started E.F. Bishop Realty, Inc. with partner Ed Bishop in 1977. In 1984 he went out on his own with Daniels & Co. Real Estate, dealing mainly with East Side and Downtown properties until retirement in 2004. Daniels sold mostly investment and commercial properties.

Some notables included the former W.T. Grant building in Downtown which later became the home to Travelers Aid, and the first store in Providence for Stop & Shop on Manton Avenue. Daniels also brought Strawberries Records & Tapes to Rhode Island as well as J. Silver Co.

Daniels was appointed to the Capital Center Commission in 1984 and has served continuously since, having been reappointed by both Mayors Cianci and Paolino. Mr. Daniels is proud of the fact that he has never missed a meeting of the Commission since his original appointment. He currently is Vice Chairman.
