No. 664 AN ORDINANCE AMENDING THE APPROPRIATION ORDINANCE,
CHAPTER 1644, BY APPROPRIATING THE SUM OF FIFTEEN
THOUSAND (\$15,000) DOLLARS TO THE ACCOUNT KNOWN AS,
"PUBLIC WORKS GENERAL ADMINISTRATION BUILDING".

Approved November 6, 1964

Be it ordained by the City of Providence:

SECTION 1. Chapter 1644 of the Ordinances of the City of Providence, as approved September 23, 1964 entitled: "An Ordinance Making Appropriation of \$46,159,931.36 for the Support of the City Government for the Fiscal Year Ending September 30, 1965", as amended, is hereby further amended by appropriating the sum of Fifteen Thousand (\$15,000) Dollars to the Account known as, "PUBLIC WORKS GENERAL ADMINISTRATION BUILDING".

SECTION 2. The said sum of Fifteen Thousand (\$15,000) Dollars as thus added and appropriated shall be charged to the General Fund from Funds Not Otherwise Appropriated.

SECTION 3. The City Controller and the City Treasurer are hereby authorized and directed to transfer the sum of Fifteen Thousand (\$15,000) Dollars from the General Fund to an Account in the Capital Funds to be known as "Public Works General Administration Building". Any unexpended balance remaining in this account upon completion of this work shall revert to the General Fund.

SECTION ⁴ 4. This Ordinance shall take effect upon its passage.

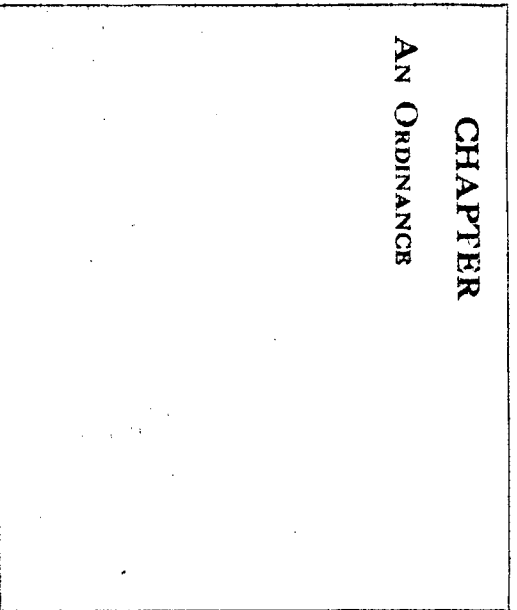

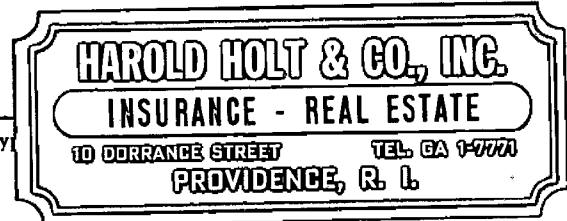

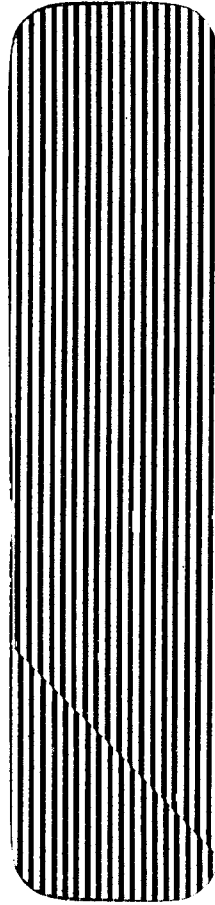
