

Dear Mr. Wexler:

As doubtless you are aware I have filed a declaration of intention to run for the office of mayor of the City of Providence in the primary to be held on September 17th next. I am taking this step because I consider it my bounden duty as a citizen. In running one of my purposes is to show the so-called leaders of the city administration that ordinary citizens still have some rights under the laws of this city and state among them being the right to think for themselves.

Some city leaders, not all, are conducting themselves in the identical manner of which they so bitterly complained when Republicans were in control of this city. There is no essential difference between a bad Republican and a bad Democrat. My aim is to start cleaning our own house lest the Republicans do it for us.

To avoid any possible criticism that might arise if a judge, while sitting on the bench, became actively engaged in partisan politics, I hereby submit my resignation as Justice of the Providence Police Court effective at your pleasure.

I regret leaving the police court but I do so with complete confidence that I have carried out my duties there in a manner that justified the confidence and trust you placed in me by electing and re-electing me to that office.

I look forward now to a new association with you in a different capacity and feel sure we will experience the same pleasant and friendly relations we enjoyed during the past ten years.

I should be pleased if you would inform the employees of the city that a change in leadership at city hall is no reason for them to fear. I know that the vast majority of them are hard-working, conscientious people and it is my purpose to improve their lot. Any employee who gives the city his best effort has nothing to fear from me if I am successful in my quest for the mayoralty.
