Section 2. The salary for each position is categorized as one (1) of seventy-seven (77) "Pay Grades", each of which contains five (5) "Steps", or, the rate listed in Section 1 above. The "Pay Grades" and "Steps" are enumerated and set forth in Section 8 (Grade 1-35) and Section 9 (Grades M1-M41,C42).

Section 3. The above paygrades and rates do not include additional compensation for employees who may be requested to work a non-standard work week or have met the CDL requirements as per the Bargaining Unit Agreement.

Section 4. The above pay grades do not include additional compensation for Supervisors who are eligible and may receive on-call pay.

Section 5. Effective with the adoption of this Ordinance, Officers, and Employees of the City of Providence may authorize Employees to perform duties of a higher rated classification, cause by leave or retirement, and that said position is funded and provided for in this Ordinance. Said assignment may be performed for a maximum of 30 days per fiscal year. Any and all other assign-

ments of out of rank nature must be approved by the City Council following petition by the Personnel Director.

Section 6. The provisions of this Ordinance shall not be construed as a ratification of any collective bargaining agreement.

Section 7. This Ordinance shall take effect upon its passage.

Section 8. Grades consistent with salary adjustments in Bargaining Unit.

## PERSONAL EXPRESSION

**COUNCILMAN JACKSON requests the privilege of the floor to speak on a point of personal expression and states:**

Thank you, Mr. President. Tonight I rise to speak in regards to this resolution. Honorable Members of the City Council, tonight I'm asking to rescind resolution number 732, which created a commission for the expansion of the City Council Offices. I think we all know, as Council leaders, that - what we need to expand, the City Council Office. I think it's been clear that we want control of the whole third floor, and I think we can get control of the whole third floor, and we don't need to have a commission to study that. Fifteen minds, fifteen voices have said that, and have made that clear, and now all we need to do is work with the administration in deciding the relocation of the offices of the third floor, so that we can have now control of what has been, and should have been our floor. I don't think we need to involve people from the outside, such as the Director of Personnel, or their designee. I don't think we need to involve the President of Local 1033 or their designee. I don't think we need to have a community representative. I don't think we need to have a business community representative. I think we've already made that decision. We already know what we need on the City Council Chambers. Let's get it done sooner than the eighteen months that this commission will study that, and that's why I stand for one, to rescind this. Also, I believe as we've always spoken of an independent body, a body separate of the administration, an equal body, and I've been a strong supporter of that, and an outspoken spokesperson in regards to that, but some of the things I see in this comprehensive plan to create a constituent focus, an accessible environment for constituent service and delivery, we already do that, Ladies and Gentlemen. We praise ourselves and pride ourself on the personnel policies - the policies and procedure manual, excuse me, that we've developed, the one that's the guiding light for all the other departments in City Hall. To create a comfortable and creative working

environment for the staff of all the departments, conducive to providing the high quality constituent services, again, that's already happening. We already have that. We don't need anyone to tell us that. And finally, develop an efficient and effective operational system amongst the three departments by reducing duplication of efforts, work processing and redundancy. As Chairman of Finance, I think that's great because that tells me that we're going to be reducing the number of staff people and the amount of time that's spent on things. So, as Chairman, and as someone who represents the taxpayers of the City of Providence, that's something that I think is positive. That's one thing then that we should definitely then look at if this is going to pass tonight. But first and foremost, I think that we who have stood to have an independent body of the City Council, equal to the administrative body of the City Council, we must realize that for any departments that come under our leadership, be it the Clerk's Office, the Internal Auditor's Office, or the City Council Office, we must allow the people that we've put in place to lead those departments to be truly the leaders, to pick and choose with our guidance the direction of those departments. Thank you.

**COUNCILWOMAN DiRUZZO rises to speak and states:**

Thank you, Mr. President. I'm going to echo - I want to echo much of what the Councilman just indicated. I really don't see a need for this. I - I don't know why we're blowing ourselves up so much. I'm very satisfied with the work that comes out of the City Council Office. I think we have some fine people that work there, very dedicated and certainly eager to please not only us but our constituencies. As a matter of fact, I have a lot of my constituents who are happy that we have such an office, and who are very pleased with the help, often times with regard to taxes, inability to pay their taxes, inability to pay the interest



on the taxes. The service that they get from this office right now, as it is, is exemplary and I have no idea why anyone would want to do this. Why do we need a commission to study and recommend the redesign of our offices? I don't get it. I'm perplexed. I - I was not happy to see this on the docket the first time it was on. I - I had a lot of questions with regard to it. I - to me it's just snuff and fluff, and I think it flies in the face of the very people that work for us each and every day and try to do a good job for both of us and all of the citizens that live within the City of Providence. So, I will vote against this because I just think we have a lot of work ahead of us. We should be studying a lot of different things that don't have to do with our office. For heavens sakes, when I got on the Council I used to do my work on a box downstairs on the first floor. I know I've been on long, longer than all of you have but we had nothing then. We have something to be proud of now. I don't see why - the only one complaint I have is that those of us who are not in leadership capacity don't have even a place, a corner in the office to sit in. So - and I think that's terrible, and it always has been as far as I'm concerned. It was very inconsiderate of the first design to leave the rest of the City Council members out of the loop when it came to giving us a desk to sit at. So, that's the only complaint that I have. So, if you want to redesign the office, you don't need a commission to do it, people. There's fifteen people elected here by the citizens of the City, and I think they want us to work on other things that are much more important to them than the redesign of our office.

---

**COUNCILMAN DE LUCA rises to speak and states:**

Thank you, Mr. President. I'm going to disagree with my colleagues on this issue. I - I do think that we need some outside advice, if we can use it. Why do you hire a lawyer? You don't know all the laws. Why do you go to a doctor? You

don't know all the medical terms. There's nothing wrong with getting some outside opinions, regardless of who they are. I have nothing to hide, no bones in my closets in the Council Office. I don't think it's any big secret. All this commission is going to do is make some suggestions. If you don't like any of them, don't take any of them. If they happen to have a - an idea, that would be helpful that we could use, we'll take that. I - I agree with Councilwoman DiRuzzo, it's about time that everybody had a - a little space that, as the Councilwoman and I do, and Councilman Hassett, we share one room. I mean we don't need it all the time. I think everybody should have a place where they can leave a pad and some - like the Charter or some things that they could go to when they're here, an extra pair of glasses, which I always have to run back down to my car for. But this commission authority is just one of giving a report and some opinions and suggestions. If we like them, fine. If we don't like any of them, we don't know it all, and I think all of us got better things to do than sit down and design an office. And we probably have talents that lie in other areas other than how things should be situated, what equipment's available. I don't know. So, I would certainly welcome outside input because I don't know anything about redesigning an office. We do want to stay up to date with the latest technologies and make everyone comfortable. Councilman Hassett talked about having a nice place where we could meet instead of getting jammed up in the Clerk's Office when we have a - an issue that a lot of people are interested in. I mean it's shoulder to shoulder in there and there isn't even any seating room. So, certainly those kinds of problems need to be solved, and I'd like - I hope that this is the opportunity to take care of both Councilwoman DiRuzzo's issue, Councilman Hassett's suggestion, and whatever other suggestions are made from anybody. I don't care if the guy from Haven Brothers, if it's a good suggestion, it's a good suggestion. We don't have to do it. Thank you.

---

**COUNCILMAN ALLEN rises to speak and states:**

Thank you, Mr. President, Members of this Honorable Body, if you recall four and a half years ago, our office was nowhere near the size that it is today. And at that time, we acquired some space. We expanded. We designed. We furnished a complete new suite of offices. And with that design came an Internal Auditor's division that was expanded. Our staff was expanded, and the City Clerk's Office - staff was expanded. From that expansion came some policy and procedures that we have done nothing but brag about for the last four years. And-and these policy and procedures have been so modeled and so great that other departments have come to us on an ongoing basis and says, what did you do and how did you do it? And our staff is often called upon to - to share their expertise to develop them policy and procedures for other departments. So, I guess the question is if we did it four and a half years ago, and we did it internally, and rightfully so, why do we need a commission four and a half years later to show us how to do it again. Well, I - I'm from the old school. I say if it - if it's not broke, don't fix it, or don't try to fix it. Our staff are probably the most - one of the most professional staffs in the City. And every day we call upon them, individually and collectively to do things that make us look good. And they do it without fanfare, and they keep us out of the frying pan. And I think this commission here puts them into the fire. And shame on us, shame on us if we don't have enough faith and confidence in the people that keep us out of the frying pan to support them and what they do. It's a sad day for this Council, and I would hope that we're big enough tonight to say we made a mistake and we're going to vote to approve this resolution, and we can move on with the business of the City.

---

**COUNCILMAN APONTE rises to speak and states:**

Part of the expansion to the third floor requires that we look at the best utilization of space, the best utilization of technology. Considering office expansion, considering what's long been talked about, having appropriate meeting and hearing space, which has been something that we've talked about for at least four and a half years that I've been on the City Council. Many members have often opined that the space in which we conduct, very often tens of millions of dollars worth of deals for the City of Providence, giving out tax stabilizations, listening to developers, are often inadequate. We're meeting in the City Clerk's Office, in a conference room that if you were to read the door carefully says alderman's coatroom. So, in order to make these decisions, you need to bring in some folks who are knowledgeable about these things and who can add some-some insight that we may have - may not have encountered. Secondly, the division of labor amongst the different departments requires us to make some decisions on what is the best location in proximity to those departments so that we can use technology better, we can use space better, we can achieve some scales of economy in putting these things together so that we give our staff, who we are all very proud of, and the staff of the City Clerk's Office, and the staff of the Internal Auditor, the best tool to continue to do the great work that they've done for us, because that's part of what we're looking at. This commission will make recommendations, will provide us with a report. It is up to this Council to make the final decisions, to enact all of them, none of them, or the ones that we believe make sense. That is - I hope that clarifies why we're including all these offices to make sure that we're using the limited space. We're taking an extraordinary step to relocate several offices that are on the third floor to other quarters. And we need to make sure that we approach this wisely, and with the most amount of information that we can glean, in order to make some thoughtful and prudent decisions.

---

**COUNCILWOMAN YOUNG rises to speak and states:**

Thank you, Mr. President. About almost four years ago when the City Council leadership embarked underneath the leadership of John Lombardi, our President, to make the office expansion, what you see here did not exist then. People were afraid then for whatever reason. They were nervous. They didn't understand what we talked when we talked about the same thing four years ago, redesign, expansion and looking at our staffing and making sure that our staff was up to snuff. We decided that we would look at those things four years ago. And again, I'm seeing the same sense of fear, apprehension, about a process that you can see the success of it today. We didn't have the number of staff people we had four years ago. We've increased the staffing. We left nobody behind. We expanded our office capacity. We want to take that to the next level. It's been almost four years. We're looking at emerging needs of our constituents. We're looking at the - the data, the comfort level of the people who work in our office. We do have the best staff, and I'm not ashamed to say that. They are tremendous. We do have some of the best leaders in the City but can we do better. We need to look - ask that question. If we can't, we can't. If we can we need to look at the potential that we may have. We will look at each staff individually and see what talents they have that we may not be utilizing right now. So, this is just looking at ourselves, and who's better to look at it than us. We're looking at this but I spoke to Vickie Virgillio, the President of 1033, last week and let her know a little bit about it and she was excited that the Council was asking them to be a part of this commission, and to look at things. They never usually get invited to these meetings until things are done. And we were looking at them in not an adversarial role because I've always felt that we worked very well with the unions, especially 1033. She was pleased that we were asking her guidance on what may be some additional union positions in our office. We have one of the unique offices that our staff are non-

union and union, and they work well together. We want to maintain that. So, this is - this is not a threat to anyone. It's just looking at what we do, expanding our offices and making sure that we have space for all the Council members, not just a few, because everybody has important work to do for their neighborhoods, making sure that we have accommodations and a work environment that conducive to the staff. And they'll have input into all of these -these decisions. It's not going to be done in a vacuum. We wanted outside expertise so that we know we're getting the best bang for our buck. We wanted outside help with this. We asked the Personnel Department. Who better than them to help direct us into the right way of doing things about hiring people and what the job specs have to look like. So, this is an inclusive process, and one of things I think this leadership has tried to do is be inclusive, and be proactive, and not leave anybody out. So, if there are more people who want to be on this commission, so be it but we think it's - it's - we have nothing to hide. This is going to be an open process. The last time we did this, Council President Lombardi had asked me to spearhead the expansion and re-organization. We did that. We were successful. Everyone here gave their ideas and their input. This is just the second phase that we could not complete then. It's not more than that and no less than that. At the end of the day, when we've been through with all of the information we gathered, and all the plans we have, you will always have the final say. The unions are not going to tell us how to run our office. They never have. The administration has never asked to be involved, and to tell us how we should do what we're doing. This is us looking at ourselves and seeing are we doing the best we can. If we are, fine. If not, we want to be able to take it to the next level. That's all. Thank you.

---

**COUNCILWOMAN DiRUZZO rises to speak and states:**

Mr. President, one of the things that I'd like to suggest is that we get moving forward with the sound system in this Chambers because I'd like to have heard everything she said but I couldn't. And I'm sure that they're not hearing everything I'm saying. That's what we should put a commission together for because the people that are sitting in the back of us don't know what we're saying, not only tonight but every time we have a meeting in here they don't know what we're saying if we're sitting at a table. The other thing, I'd like to see a commission established for with a group of people that you're speaking of is one to study all of the departments in this City, my colleagues, because no matter what we put in the City Council Office, or how sophisticated we get, if we can't talk through our computers to the other departments, which we are not aware that we can, then what good is it. Look at the Bureau of Vital Records - Vital Statistics. They are overwhelmed with business down there and they have an antiquated office where they don't even have space for their records. Speaking of space, look at the Board of Canvassers. Look at the Board of Licenses. We ought to be ashamed at some of the conditions of these offices. Look at the Department of Public Works and look at the Department

of Inspections. They don't have enough room for their records either. What are we talking about. So, no matter how sophisticated the City Council office gets, or how big and how beautiful it looks, and how much further we can look into the future, it's not going to make a difference if you can't do it for the other departments contained within this City of Providence that are doing the work for us on a daily basis. We want them to be productive. We want them to be able to produce. We want them to be able to address the needs of the people, and yet we do not give them what they need to run and operate their departments in a sophisticated way. So, sorry I'm ranting and raving but this has been going on in my head, and in my mind for many years now.

So, when we look at commissions and establishing commissions, and being inclusive of all these other committees, then we should be looking at it globally so we address the needs of all of the people that work in this City, of all of the needs that they have within the departments when they can't produce for us because they don't have the equipment to do so, and certainly a lot of them don't have the money to have their staff trained in an appropriate fashion. So, we've got a lot of things we should be establishing commissions for. Thank you.

personal expression and states:**

The first issue at hand is the oncoming snowstorm, that's coming this weekend. And the reason why I'm standing up is because of several things. The last time we had a snowstorm, the last snowstorm in the City of Providence this year, our illustrious Director of DPW stated to the press after the snowstorm was over, a couple of days after the snowstorm, that 80% of the City was plowed. And he was exalting it like it was a great victory. But it's not a victory. A hundred percent of the City has to be plowed. And if I remember, hopefully Council member will correct me, but I and other Council members, and I believe Councilman Luna, stood up and said I'm glad the 80% got plowed because the other twenty was my ward. And I know some Councilmen stood up and said but my ward was plowed and it was a wonderful thing. Well, folks, at the end of this snowstorm, the next Council meeting when I said we all should stick together on this issue, and someone said, oh, no, no, my ward was fine, if your ward's not plowed but mine and Mr. Luna's is, Councilman Luna's, we're going to say what a great job. But the point is we have to stick together on this issue. The whole City has to be plowed 100% because come Sunday morning, and Monday morning, when I get the phone calls

from my constituents saying please plow me out, please shovel my driveway because somebody said I'm going to show up and do it and they don't. Okay. Do me a favor. Do the job. Plow the streets, then do the PR stunt and go around and plow and shovel people's driveways. But let's get the streets done first because if the sidewalks are shoveled but the streets aren't, well, guess what, it's still a failure because then the ambulance can't get to their door.

So, I ask, and I urge my Council colleagues to keep the pressure and heat on DPW, the Director in particular, who doesn't know much about the garbage ordinance, and thinks 80% is a victory, to make sure he gets 100% done. And if he can't, then let's revisit what he's doing, and I'll call upon the Chairman to bring him in to revisit what he's doing down there. I know the worker's are doing - that do a good job but the bottom line is if the top doesn't know what's going on and doesn't direct the workers, and doesn't follow up, it doesn't matter how well they shovel your individual street. So, please, I urge the DPW director to get 100%. And by the way, I don't want to hear 100% just to say it because we'll all know if it's true or not by the way, because we live in these wards, and then I'll have to deal with-a caller called up today on - on the show for me and they thanked me because they called up the last snowstorm, they called up the City of Providence to have their

street plowed, no one showed up. They called me up and then I had my own crew shovel them out, plow the streets. Well, folks, government's about getting government to do what they're supposed to do, provide the city services that the taxpayers are paying. The volunteer stuff can go later on. Let's get city services to work. That's that. Second issue, I would like to also report some progress on the police and fire detail delinquent accounts. As I am sure some of you heard, maybe much to your consternation that I was on the radio and other things, in the press concerning the accumulative about \$1.4 million dollars worth of past police and fire detail. Well, in that laundry list of illustrious businesses and institutions, and non-taxable colleges, from Brown University on down, RISD, and other utility companies, another company got the message. I just heard recently that Brown University after the discussion on the radio issued a press release saying they're going to pay their bill. And by the way, last week

a utility company called me up and said, by the way, Councilman, we got your message. It's not \$30,000.00 we owe the City, it's almost ninety, so they paid that bill. The point, folks, is we all have to be ever vigilant. We're going to keep on continuing, and we need to do everything we can to help the taxpayer. So, for next year's budget, we all read in the paper about what's happening up at the State House, the federal government, you know what that means. It's coming down here. The big freight train's coming here. So, all I ask is I urge all of us to continue to monitor the budget, continue to look for savings, and continue that process. With that, thank you.

The air in our city contains unacceptably high levels of smog and soot, air toxics and global warming pollution. The air Providence residents breathe every day does not meet minimum federal standards for air quality. Smog and soot put the health of our children and senior citizens at risk. Smog leads to the formation of ground level ozone, which triggers asthma attacks and has been linked to new cases of adult asthma. According to the American Lung Association of Rhode Island, over 100,000 Rhode Islanders suffer from asthma, including 10,000 Providence residents. Whereas, Exposure to air toxics, like benzene, can lead to the development of cancers like leukemia. The air in Providence County has benzene levels that are eleven times higher than the accepted cancer risk. Meanwhile global warming pollution is creating hotter summers and creating more extreme weather patterns. Whereas, the frequency of air alert days in Rhode Island is on the upswing. On these days seniors, children and even active adults are warned to avoid outdoor exertion because the air may be dangerous to their health. Asthma remains the number one inpatient, outpatient and emergency room diagnosis in pediatrics, and inhalers have become as common as lunchboxes in schools throughout our state. Whereas, Cars and trucks in Rhode Island emit 40% of the smog forming nitrogen and 36% of the hazardous air toxics found**

**in our state's air. The average car on the road today will spew 50 tons of carbon dioxide, the leading cause of global warming into our air. In order to have healthier air in Providence, we must clean up our cars. Whereas, Providence should lead the way in reducing automobile pollution by adopting a fuel-efficient vehicle procurement policy, which will reduce the amount of pollution created by the city fleet. Massachusetts, New York and other New England states have already implemented such programs and are beginning to see the benefits". Section 1, "Among the most fuel-efficient vehicles, a preference shall be given for vehicles with more than 65% of their value from domestic production and for vehicles made in U.S. unionized factories", seconded by COUNCILWOMAN WILLIAMS.**

Resolution in Opposition to the USA Patriot Act.

*Whereas*, The City of Providence recognizes that a threat to any one person's Constitutional rights is a threat to the rights of all; and

*Whereas*, The City of Providence has been and remains committed to the protection of civil rights and liberties for all residents; and

*Whereas*, The United States Constitution guarantees all persons living in the United States certain fundamental rights including freedom of religion, speech, assembly and privacy; protection from unreasonable searches and seizures; due process and equal protection; and access to counsel, presumption of innocence and a fair, speedy public trial; and

*Whereas*, A great crime against humanity occurred on September 11, 2001, resulting in new federal laws and enforcement powers, including the USA Patriot Act signed by President George W. Bush on October 26, 2001; and

*Whereas*, The USA Patriot Act was written to respond to the attack on our nation, it weakens, contradicts and undermines the basic constitutional rights outlined above. The Act, a 342 page document, was hastily enacted in six weeks without public hearings, or a Congressional "mark-up"; and

*Whereas*, Examples of the Patriot Act's threat to these fundamental rights include the Government's expanded power to: engage in

limited judicial supervision of telephone and Internet surveillance; grant law enforcement and intelligence agencies broad access to sensitive medical, mental health, financial, and educational records with little, if any, judicial oversight; expand the government's ability to conduct secret searches of individual's homes and businesses, including monitoring what books are bought from bookstores or borrowed from libraries; and limits the disclosure of public documents and records under the Freedom of Information Act; and

*Whereas*, The Department of Justice interpretations of the Patriot Act and Executive Orders appear to impact on selective racial and religious groups including residents of other nations. This has caused alarm among many of our local citizens and non-citizens who fear an emergent climate for racial and ethnic profiling. This is especially disconcerting because the City of Providence is home to a diverse population, whose contributions are vital to the city's character and function; and,

*Whereas*, Many other communities and over 120 cities throughout the country have enacted resolutions reaffirming support for civil rights and civil liberties in the face of government policies that threaten these values, and are demanding accountability from federal agencies regarding the use of these new powers.

*Now, Therefore, Be It Resolved*, That the City Council of the City of Providence, affirms that any efforts to end terrorism not be waged at the expense of the fundamental civil liber-

ties of the people of Providence, and all citizens of the United States; and

*Be It Further Resolved*, That the City of Providence affirms the rights of all people, including United States citizens and citizens of other nations, living within the City in accordance with the Bill of Rights and the Fourteenth Amendment of the U.S. Constitution; and

*Be It Further Resolved*, That the City Council of Providence urges the city administration and its citizens during the course of their daily life to be guided by the collective responsibility and obligation of safeguarding the constitutional protections afforded all people of our city. The Council recognizes that this is the paramount responsibility of local law enforcement personnel, appointed and elected government offices that are ultimately responsible for upholding the solemn oath they have taken to

preserve, protect and defend the Constitution of the United States and the State of Rhode Island, and

*Further Resolves*, That the Providence City Council calls on our United States Representatives and Senators to monitor the implementation of the Act and Executive Orders cited herein and actively work for the repeal of the Act or those sections of the Act including Executive Orders that violate fundamental rights and liberties as stated in the United States Constitution and its Amendments.
