CALENDAR YEAR 1972

For the year 1972, the Building Board of Review held ten (10) meetings. At these ten meetings, regular applications for variances or modifications were heard.

Of the 33 regular applications for variances or modifications of the Building Ordinance, 9 of these petitions were granted as filed, 20 granted with provisions, 3 were denied and 1 was continued into the new year. With 29 of the 33 applications eligible to take out building permits, 6 were for high rise apartments which, when completed, will result in approximately 760 additional units of housing for public housing, low income, medium income and housing for the elderly.
