Charles F. McElroy was a native of the City of Providence which he served faithfully for more than a quarter of a century in several official capacities.

He received his education at Tyler School; LaSalle Academy and English High School.

Early in his life he developed a keen interest in politics and enlisted as a worker for the Democratic cause, at a time when his party was struggling for recognition. His persuasive ability to bring harmony to dissident groups established him as a person to consider, for party leadership, and accordingly, the Democratic leaders of that time adopted him.

During the administration of the late Governor Theodore F. Green, Mr. McElroy was appointed as State Director of Public Works and continued in that office with the administration of former Governor Robert E. Quinn.

In 1941 he became the Director of Public Works during the administration of former Mayor Dennis J. Roberts and was reappointed by former Mayor Walter H. Reynolds.

Mr. McElroy served as Democratic City Chairman for more than one quarter of a century, a party post he administered with great tact.

As a citizen of this community he enjoyed the respect of all with whom he had contact, and as a father he assumed his parental obligations of caring for his children as a widower which gained for him additional respect.
