



The above referenced drawing has been reviewed and approved by the Department of Public Works. As per their request, Outlet Communications, Inc., has agreed to indemnify the City of Providence against any claims by third parties resulting from the construction of the three flagpoles. Please see the attached copies of letters from Mr. Steven Kile, The Providence Partnership dated November 19, 1987 and Mr. David Henderson, President of Outlet Communications, Inc. dated December 16, 1987 to Mr. James Suzman, Acting Director, Department of Public Works.


Dear Mr. Suzman:

We are writing on behalf of our client, Outlet Communications, who own and occupy Broadcast House at 111 Dorrance Street. Our client wishes to place three flagpoles in front of their main entrance on Dorrance Street within the city sidewalk.


RE: Indemnification Letter

Approximately two years ago, Outlet Communications, who own and occupy Broadcast House, 111 Dorrance Street, requested permission of the City to install three flagpoles. The flagpoles are to be located within the City sidewalk adjacent to the curb near the front entrance of Broadcast House on Dorrance Street.

After numerous but unsuccessful attempts to establish a hearing date before the City Council, your office was contacted by John Sawhill, Vice President and General Manager of WJAR-TV. We were instructed to contact the Department of Public Properties. Mr. Vincent Capuano, Director of Public Properties, recommended that the drawings be submitted to the Department of Public Works. This was done.

This project was reviewed and approved by the Department of Public Works, provided that the City be indemnified against any claims by third parties resulting from such construction.

On December 16, 1987, I wrote an indemnification letter to James Suzman, Acting Director at the Department of Public Works. Mr. Suzman stated this matter would be sent to John D'Amico, Attorney-at-Law in the City Law Department for final review.

On May 11, 1988, Mr. John D'Amico informed us that the City of Providence was unable to find the original petition and that it would be necessary to refile a new petition with drawings through the City Clerk's office. This was done on May 24, 1988 with an updated certificate of insurance.

On August 26, 1988, we contacted Ms. Rose Mendonca, City Clerk, who stated the petition was on the schedule for the City Council meeting of August 24, 1988. However, it was not acted on because Mr. John D'Amico in the City of Providence Law Department had not reviewed the petition.

If it is possible, we are asking your office to help resolve this apparent communications problem.



Dear Mr. McDaniel:

On this date, Outlet Company's petition to erect flagpoles was considered by the Council's Committee on Public Works. After acceptance of the indemnification agreement, the Committee inquired into the Outlet Company's continued obligation to maintain general liability coverage on the flagpoles in the amount of \$1 million with the City as an additional named insured. It is the Committee's understanding that the policy of \$1 million with the City as a named insured will be maintained in effect for the duration of the flagpoles' existence. Further, that should such policy terminate, the City is automatically empowered to remove the flagpoles and charge the cost for such removal to Outlet.

If this is the Outlet's understanding of the agreement, kindly acknowledge the same to myself and to the Deputy City Clerk, Michael Clement, City Hall, Providence, Rhode Island 02903 prior to 14 October 1988 for consideration at the next Council meeting. Understandably that target date is restrictive and should your acknowledgement be received thereafter, it will be placed on the Council's next agenda.

This letter is in reply to your letter of October 12, 1988 regarding Outlet Communications continued obligation to maintain general liability coverage on the flagpoles to be erected in front of Broadcast House.

Please note that it is the intention of Outlet to continue to maintain such general liability coverage indefinitely. It is Outlet's understanding that it will maintain the policy for general liability coverage in the amount of \$1 million with the City as the named insured and will be in effect for the duration of the flagpoles' existence.

All of Outlet's insurance policies are issued for a period of one year and are renegotiated yearly with new policies issued. The terms, stated in our certificate of insurance issued to you, state that you will be notified if the coverage is cancelled.
