RESOLUTION OF THE CITY COUNCIL

No. 312

Approved May 23, 1978

RESOLVED, that his Honor the Mayor is authorized, with the recommendation of the City Council to accept from the St. Anthony's Church Corporation of Rhode Island, that certain lot or parcel of land with all the buildings and improvements thereon, situated on the northerly side of Plainfield Street, in the City and County of Providence, and State of Rhode Island, bounded and described as follows:

Beginning at a point in the northerly line of Plainfield Street at the southwesterly corner of land now or lately of John E. Gallo et ux, said point of beginning being the southeasterly corner hereof; thence northerly bounding easterly on said Gallo land in part, in part on land now or lately of Ernest S. Iannuccilli et al, and in part on land now or lately of Mary S. Quattrucci et al, and in part on land now or lately of Mary S. Quattrucci et al, in all one hundred forty-nine and 88/100 (149.88) feet to a corner; thence westerly bounding northerly on said Quattrucci land in part, in part on land now or lately of Adele W. Marinosci, in part on land now or lately of David N. Bock, Sr., et ux, and in part on other land of this Grantor in all one hundred fifty-one and 60/100 (151.60) feet to a corner; thence southerly bounding easterly on other land of this grantor one hundred fifty-one and 27/100 (151.27) feet to a point in the northerly line of said Plainfield Street, which point is one hundred fifty and 90/100 (150.90) feet westerly from the point of beginning; thence easterly bounding southerly on said Plainfield Street one hundred fifty and 90/100 (150.90) feet to said Gallo land at the point of beginning.

The said land and building are to be accepted from the St. Anthony's Church Corporation of Rhode Island for use as a proposed site for a community development facility. Said acceptance of property will be purchased with funds from the Mayor's Office of Community Development.


Dear Mrs. Mendonca:

Gallo et ux, said point of beginning being the southeasterly corner hereof; thence northerly bounding easterly on said Gallo land in part, in part on land now or lately of Ernest S. Iannuccilli et al, and in part on land now or lately of Mary S. Quattrucci et al, in all one hundred forty-nine and 88/100 (149.88) feet to a corner; thence westerly bounding northerly on said Quattrucci land in part, in part on land now or lately of Adele W. Marinosci, in part on land now or lately of David N. Bock, Sr., et ux, and in part on other land of this Grantor in all one hundred fifty-one and 60/100 (151.60) feet to a corner; thence southerly bounding easterly on other land of this grantor one hundred fifty-one and 27/100 (151.27) feet to a point in the northerly line of said Plainfield Street, which point is one hundred fifty and 90/100 (150.90) feet westerly from the point of beginning; thence easterly bounding southerly on said Plainfield Street one hundred fifty and 90/100 (150.90) feet to said Gallo land at the point of beginning.

Said land and buildings are to be accepted from the St. Anthony's Church Corporation of Rhode Island. Said acceptance of property will be purchased with funds from the Mayor's Office of Community Development in the amount of approximately \$175,000.00.
