The City Treasurer has received an offer made by Herbert H. Hicks and wife Anne W. Hicks, both of Providence, Rhode Island, of \$1,623.50, and also the amount subject to the 1976 taxes, and as the period for the redemption of this property has expired, this offer is hereby approved in accordance to the law thereto appertaining.

If said real estate shall not be redeemed within said thirty days, the City Treasurer is hereby authorized to sell and convey to the said Herbert H. Hicks and wife Anne W. Hicks, or nominees for the price herein approved.

SUBJECT: Referral No. 1947 - BID TO PURCHASE LOT 163 ON ASSESSOR'S
PLAT 67 ON WEST PARK STREET

Gentlemen:

This department is in receipt of a communication from the office of the City Treasurer regarding a bid to purchase city owned property designated as Lot 163 on Assessor's Plat 67 on 120 West Park Street in an M-1 zone. The bid is from the owner of Lot 161 located on 138 West Park Street.

Inspection revealed that Lot 163 is vacant and unimproved, heavily overgrown with trees and brushes. A two family structure, vacant and boarded up, is located on adjacent Lot 164. The residential structures in the area are in fair condition. West Park Street is a dead-end street closed by a wall extending the south-western property line of Lot 161. At the end of West Park Street and on Lot 160 several junk cars have been observed.

Since this department is aware of no present or future plans for the use or disposition of this property, no objection is offered to the proposed sale.

No objection is offered by this department to the granting of the petition.

The Commission VOTED to offer no objection to the granting of this petition.
