


PETITION TO THE CITY COUNCIL

Subject: Referral No. 2009 Street Betterment - Houghton Street

Gentlemen:

The subject petition from the Providence City Council Committee on Public Works proposes the betterment of Houghton Street from Veazie Street to the westerly lot line of Lot 396 on Assessor's Plat 78. The proposed street improvement consists of a layout of the street, definement of grade, installation of curbstones, drainage and sewer. This petition was submitted by Bertram M. Brown, President of Vocational Resources Incorporated at 100 Houghton Street, Providence, Rhode Island.

A field inspection revealed that Houghton Street is a private right-of-way and is paved with asphalt. Curbstones have been installed at the southerly side approximately 200 feet from Veazie Street with catch basin. Since this paved private street is now serving the existing uses at both sides of the street in question, it will be a financial burden for the City of Providence to further improve and maintain it. Therefore,
