Dear Councilman Hassett,

As we discussed yesterday, we are assisting Shank/Balfour-Beatty Inc. in meeting traffic- and noise-related specifications for the Construction of the Narragansett Bay Commission's Combined Sewer Overflow Tunnel project.


One of the work areas required for the construction of this project is property on either side of Okie Street, between Calverley Street and Bath Street (please see the attached sketch). It will be necessary for the Contractor to occupy Okie Street for extended durations throughout the three-year construction period. We are, therefore requesting on their behalf, that the City Council resolve to temporarily close Okie Street for a three (3) year period, starting as soon as possible.

This office is preparing the necessary traffic study, including traffic detour design, to address the negligible volume of thru traffic that must be detoured for this closure. We have been, and will continue to be, in contact with Ms. Testa of the City's Traffic Engineering Department. It should be noted that no privately held properties rely on this section of Okie Street for sole right-of-way access. In fact, only one active property, Iannuccillo Construction, abuts it. This property uses Calverley Street for their day-to-day property access needs.


The Contractor has an immediate need to occupy this section of Okie Street, and they would appreciate any priority which the Council could place on this request.
