## INVOCATION

The Invocation is given by **COUNCILMAN NICHOLAS J. NARDUCCI, JR.**

“We rise tonight remembering the careless nonsense of the shootings and the killings in our schools, in our malls and in our movie theatres. At what point does it end. We need moving forward here in Rhode Island and in Providence, we need to stop talking about the safety of our schools. We need to invest no matter what it cost to make our schools safe for the children that attend them. As a grandfather, I look at my two babies and I shake my head. I am looking in the world they’re growing up in. What’s it going to be like when they are seventeen or eighteen years old if it’s the way it is now and continues to stay this way. Back a few years ago when we had these school shootings, if you guys remember we sat with the Superintendent back then and we were supposed to get bullet proof glass in the schools and we were supposed to get all this protection in the schools and nothing ever came about. Again, it was all talk. Here we are so many years later doing the same thing. What do they do? They want to take our officers out of the schools. We go to other areas that are putting officers in every single school including high schools. That we need to do here in Providence. I don’t want to be on the side that says we should have done it. We have to do it. Some of us council people only have five months left and some of you guys are on your way back. So, it’s really going to be up to you guys. We cannot let the State tell us how to run the safety in our schools because first of all the State is doing a terrible job with our schools anyway, but the safety of our kids is our problem. We have to stay together on this. I am disgusted in the whole system period. You know the black rubber door stoppers that I said about six years ago, every school teacher should have in their desk draw is a black rubber stopper. What do you do with those? Something is going down you shove them under the door so they can’t open the door. A rubber stopper probably about \$11.00 dollars a piece. I promised myself I wouldn’t go on and on because I could, but I would like at this point in time is to really take a moment of silence for the victims between the school shootings, the mall shootings, the church shooting recently, their families what they have to go through and let’s look at our families and God please make sure we pull together and make the right decisions for especially our children in the Providence Public School system. In the name of the Father, the Son and the Holy Spirit. Amen.”

### **COUNCIL PRESIDENT IGLIOZZI**

An Ordinance in Amendment of Ordinance No. 2022-12, No. 160, Approved April 25, 2022, Entitled: "An Ordinance Apportioning the Fifteen Wards", As Amended.

**SECTION 1.** Section 204 of the Code of Ordinances is hereby amended to read as follows:

The City of Providence is hereby apportioned into fifteen wards in accordance with Section 204 of the Providence Home Rule Charter of 1980, as approved by the Electors of the City of providence at the General Election held November 4, 1980 and validated by the General Assembly on May 7, 1981.

### **FIRST WARD**

The First Ward of the City of Providence shall consist of all that part of the City bounded by a line beginning at the intersection of Henderson Expy and the Providence - East Providence Boundary line; thence West on Henderson Expy; thence North on River Dr; thence West on Angell St; thence South on Brook St; thence West on Waterman St; thence South on Thayer St; thence West on Charlesfield St; thence South on Brown St; thence West on Power St; thence Northwest on S Main St; thence Northwest on N Main St; thence West on Park Row; thence Southeast on the Mosshasuck river; thence Southwest on Steeple St; thence west on Memorial Blvd; thence South on I- 95; thence Northeast on I- 195; thence southeasterly on Providence River; thence northeasterly on the Providence - East Providence boundary line to the point of beginning.

## SECOND WARD

The Second Ward of the City of Providence shall consist of all that part of the City bounded by a line beginning at the intersection of Power St and S Main St; thence East on Power St; thence North on Brown St; thence East on Charlesfield St; thence North on Thayer St; thence East on Waterman St; thence North on Brook St; thence East on Angell St; thence South on River Dr; thence East on Henderson Expy; thence North on the Providence - East Providence border; thence west on the Providence - Pawtucket border; thence South on Hope St; thence Southeast on Blackstone Blvd; thence Southwest on North Ave; thence South on Hope St; thence East on 8th St; thence Southeast on Winfield Rd; thence Southwest on Lorimer Ave; thence East on Rochambeau Ave; thence South on Elmgrove Ave; thence West on Doyle Ave; thence North on Taber Ave; thence West on Emeline St; thence South on Morris Ave; thence West on Olney St; thence South on N Main St; thence South on Benefit St; thence West on Meeting St; thence South on N Main St; thence Southeast on S Main St to the point of beginning.

## SIXTH WARD

The Sixth Ward of the City of Providence shall consist of all that part of the City bounded by a line beginning at the intersection of the Providence - Johnston boundary line and the Woonasquatucket river; thence Northwest on the Providence - Johnston boundary line; thence Northeast on Manton Ave; thence east on Chalkstone Ave; thence South on Bergen St; thence West on Regent Ave; thence South on Huron St; thence West on the Northern boundary of census block 440070022003006; thence South on Academy Ave; thence West on Atwells Ave; thence South on Putnam St; thence West on Amherst St; thence Northwest on Manton Ave; thence Southwest on Salmon St, continuing on the western boundary of census block 440070019003001; thence east on Hwy 6; thence Southerly, Westerly, and Northwesterly on the Woonasquatucket river to the point of beginning.

## SEVENTH WARD

The Fourteenth Ward of the City of Providence shall consist of all of that part of the City bounded by a line beginning at the intersection of Pembroke Ave and Eaton St; thence East on Eaton St; thence North on Douglas Ave; thence Northeast on Corina St; thence North on Appian St; thence Northeast on Corina St; thence Northeast on the eastern boundary of Corliss / Mansion Park; thence Northeast on Hawkins St; thence Northwest on Louisquisset Pike; thence West on Branch Ave; thence South on Moy St; thence West on Concannon St; thence Northwest on Douglas Ave; thence Southwest on the Providence - North Providence boundary line; thence Southeast on Admiral St; thence West on Texas Ave; thence South on Gentian Ave; thence East on Isabella Ave; thence South on Enfield Ave; thence Southeast on Smith St; thence North on River Ave; thence Southeast on Eaton St; thence South on Tyndall Ave; thence Southeast on Smith St; thence North on Pembroke Ave to the point of beginning.

## FIFTEENTH WARD

The Fifteenth Ward of the City of Providence shall consist of all of that part of the City bounded by a line beginning at the intersection of Terrace Ave and the Providence - Cranston boundary line; thence Northwest on Terrace Ave; thence West on Shafter St; thence North on Laurel Hill Ave; thence East on Plainfield St; thence North on Webster Ave; thence East on Eastwood Ave; thence South on Heath St; thence East on Laban St; thence Northeast on Plainfield St; thence Northwest on US Hwy 6; thence Northeast on the western boundary of census block 440070019003001, continuing on Salmon St; thence Southeast on Manton Ave; thence East on Amherst St; thence North on Putnam St; thence East on Atwells Ave; thence Southwest on US Hwy 6; thence South on State Rte 10; thence Northerly and Westerly on the Providence - Cranston boundary line to the point of beginning.

**SECTION 2.** It shall be understood and intended that in bounding and describing the said Wards, that the said boundary lines of streets, streams, rivers and railroads is meant in all instances the central line of such street, stream, river or railroad, unless the same be otherwise specified.

**SECTION 3.** This Ordinance shall be liberally construed to effectuate the purposes thereof and to apportion the City into fifteen wards in compliance with the Home Rule Charter of the City of Providence. It is intended that the fifteen wards described herein completely encompass all the area within the City and contain all the citizens resident in the City. It is further intended that the ward boundaries provided for in this Ordinance result in the creation of wards containing substantially equal population, that natural boundaries be used and recognized neighborhoods be included within wards without arbitrary divisions thereof, so far as practicable.

**SECTION 4.** This Ordinance shall take effect upon its passage; provided, however, that the provisions hereof shall first be effective in connection with elections to be held on or subsequent to the first day of September, 2022, and for the purpose of greater clarity, the first election under the provisions of this Ordinance for City Council Wards hereby created, shall be held on the Tuesday next after the first Monday in November, 2022, and the first primary election under the provisions of this Ordinance for nomination of candidates for City Council from each of the fifteen wards shall be held on the second Tuesday after the first Monday in September, 2022, provided however, that if any of the provisions of this Ordinance or the application of such provision to any court of competent jurisdiction, or if any action performed under the provision of this Ordinance is restrained or enjoined by any court of competent jurisdiction, the remaining provisions of this Ordinance shall not be deemed impaired or affected thereby but shall be deemed to remain in full force and effect.

Resolution Requesting the Attorney General and the Department of Business Regulation take enforcement action against businesses illegally selling fireworks.

**WHEREAS**, Over the past several weeks, cities across the country have experienced significant increases in the incidences of fireworks being used at all times of the night and often directly above residential neighborhoods; and

**WHEREAS**, Rhode Island General Law §11-13-1 prohibits the sale or use of aerial fireworks without first obtaining a permit from the local Fire Marshall; and

**WHEREAS**, There are numerous businesses throughout the state, and specifically within the City of Providence, that are currently offering aerial fireworks for sale to the public; and

**WHEREAS**, The Department of Business Regulation has the authority to take enforcement action against any business entity that is operating without first obtaining the proper licenses; and

**WHEREAS**, The use of aerial fireworks without a permit creates a public health and safety hazard as the noise affects the quality of life for local residents and the improper use of an aerial firework can significantly harm persons and property in the area; and

**WHEREAS**, In order to address the significant increase in illegal fireworks activity, Providence City Councilwoman, Jo-Ann Ryan convened city stakeholders to identify areas of concern. Subsequently, the Providence Chief of Police in collaboration with both the City and State Fire Marshalls established a task force dedicated to preventing the sale and discharge of illegal fireworks within the City; and

**WHEREAS**, The task force dedicated over a dozen law-enforcement officials to respond to calls involving fireworks and other noise-related incidents, resulting in several arrests and the seizure of numerous fireworks; and

**WHEREAS**, In addition to increased enforcement, the City Council also worked with Providence Police and Fire Departments, as well as the City Administration, to initiate a social media campaign focused on educating the public on the laws surrounding fireworks, how to report violators of the law, and how to assist in the identification of locations where fireworks are being discharged; and

**WHEREAS**, While the City of Providence has begun efforts to better manage the use of fireworks within the limits of the City, it is necessary that the Attorney General and the Department of Business Regulation recognize the seriousness of this issue and take the necessary enforcement actions against local businesses who are illegally selling aerial fireworks without the appropriate permits.

## PERSONAL EXPRESSION


### **COUNCILOR KERWIN Requests the privilege of the floor to speak on a Point of Personal Expression and states:**

"I just want to speak briefly, for those of you that don't know there was an incredibly devastating incident in a middle school in Providence last week at Nathanael Greene, it's a school in my neighborhood and it was just days after the tragedy in Uvalde Students saw one of their classmates carrying a gun at school. What is so frankly flabbergasting is that school administrators knew about it for over an hour and they did nothing. They didn't call the authorities, they didn't get help and in the wake of this really terrifying moment they just sat and waited and they let the students go home. It wasn't until dismissal that they issued a locked down while students were already leaving the school. You can imagine how devastated parents are. I have been getting calls all week telling me students aren't going to school because they feel scared and they don't feel comfortable. So, I just wanted to stand and echo the Mayor's calls. I believe the principal needs to be held accountable for this. Not only have they not responded adequately, but they refused parents requests and my requests for a meeting and they have totally just disregarded the feelings of fear that our kids are feeling which are only magnified by this terrible act that happened in Texas last week. I had a really great conversation with my colleagues, with Councilwoman Castillo and Councilwoman Harris. Councilwoman Castillo is planning a School Safety Action which is next Monday the 13<sup>th</sup>. So, we really need to come together and we also need some accountability from that principal. While we unfortunately don't have the schools in our control, we need answers here because our kids are terrified and this is on our watch. Thank you."
