An Ordinance to Appropriate \$15,000,000 and to Authorize the Issuance of Not in Excess of \$15,000,000 General Obligation Bonds for the Purpose of Acquiring and Preserving Open Space and Acquiring, Preserving, Restoring or Improving Recreational Areas.

Be it Ordained by the City of Providence:

Section 1. The sum of \$15,000,000 is hereby appropriated for the purpose of acquiring and

preserving open space and acquiring, preserving, restoring or improving recreational areas as set forth in Chapter 616 of the Rhode Island Public Laws of 1987.

Section 2. The sum of not in excess of \$15,000,000 shall be borrowed at one time or from time to time for the purpose of financing the project described in Section 1. The City Treasurer, with the approval of the Mayor and the Committee on Finance, is authorized to accept

and approve bids at one time or from time to time for not in excess of \$15,000,000 general obligation bonds, to determine and approve the manner of sale, denominations, interest rate, and other terms and conditions of the bonds, and to issue the bonds.

Section 3. The City Treasurer, with the approval of the Mayor and the Committee on Finance, is authorized to issue from time to time interest bearing or discounted notes in anticipation of the bonds authorized by Section 2 in accordance with Section 5 of Chapter 616 of the Rhode Island Public Laws of 1987 and to determine and approve the manner of sale, denominations, interest rate, and other terms and conditions of the notes.

Section 4. The bonds and notes shall be signed by the manual or facsimile signatures of the Treasurer and the Mayor and shall bear the Seal of the City of Providence or a facsimile thereof.

Section 5. The estimated maximum cost of the Project described in Section 1 hereof is \$15,000,000, which entire amount is being appropriated hereby.

Section 6. It is hereby determined that the period of usefulness of the Project described in Section 1 hereof is thirty (30) years.

Section 7. It is hereby determined that the net debt of the City of Providence after the issuance of the bonds authorized hereby will be \$20,699,102.

Section 8. It is hereby declared that the bonds authorized hereby will be within all debt and other limitations prescribed by the Constitution and Laws of the State of Rhode Island.

Section 9. This Ordinance shall take effect upon its passage.
