

## ORDINANCE SECOND READING

**The Following Ordinance was in City Council March 21, 2019, Read and Passed the First Time and is Returned for Passage the Second Time:**

**COUNCILWOMAN LAFORTUNE, (By Request):**

An Ordinance Relating to Article IV, Chapter 17, Section 17-192(f) of the Code of Ordinances (Disability Waiver Request) (Sugar Rodriguez).

SECTION 1. Notwithstanding the language of Section 17-189(6) of the Code of Ordinances which provides that the application to accomplish such [accidental disability] retirement must be filed within eighteen (18) months of the date of the accident," the Retirement Board of the City of Providence, may consider and act upon the accidental disability retirement application of Sugar Rodriguez, even though more than eighteen (18) months have passed since the date of the accident which is the averred proximate cause of the above-named applicant for a disability retirement allowance.

SECTION 2. Said application shall be subject to and considered in accordance with all other applicable ordinances, regulations, standards and practices relating to accidental disability retirement applications.

SECTION 3. This Ordinance shall take effect upon its passage.

Resolution Recognizing April as Sexual Assault Awareness Month.

*WHEREAS*, Sexual Assault Awareness Month is intended to draw attention to the fact that sexual violence is widespread and impacts every community member of Providence and Rhode Island; and

*WHEREAS*, Rape, sexual assault, and sexual harassment impact our community as reflected in estimates that show that one in eight women in Rhode Island has been sexually assaulted during her lifetime, and nationally, nearly one in five women and approximately one in 71 men will be raped at some point in their lives; and

*WHEREAS*, Child sexual abuse prevention must be a priority to confront the reality that in this country one in six boys and one in four girls will experience a sexual assault before the age 18; and

*WHEREAS*, Studies have consistently found that people with developmental disabilities face higher rates of sexual assault, with 15,000 to 19,000 raped each year in the United States; and

*WHEREAS*, Individuals, organizations, and public officials must work together to educate our community about sexual violence prevention, to support survivors, and to speak out against harmful attitudes and actions; and

*WHEREAS*, With leadership, dedication, and encouragement, there is evidence that we can successfully prevent sexual violence in Providence through increased education, awareness, and community involvement; and

**WHEREAS**, National organizations, such as the National Sexual Violence Resource Center, and local advocacy groups, such as Day One, the Sexual Assault & Trauma Resource Center, promote April as Sexual Assault Awareness Month as part of a campaign to prevent sexual violence; and

**WHEREAS**, The City of Providence strongly supports the efforts of national, state, and local partners, and of every citizen, to actively engage in public and private efforts to prevent sexual violence.

**NOW THEREFORE BE IT RESOLVED**, That the City Council of the City of Providence does hereby join advocates and communities across the country in supporting efforts to prevent sexual violence; and

**BE IT FURTHER RESOLVED**, That the City of Providence recognizes the month of April each year as "Sexual Assault Awareness Month."

### COUNCILMAN CORREIA

Resolution Requesting the Director of Public Works clean all debris and sweep the sidewalks on various streets along the Providence Business Corridors.

**WHEREAS**, According to Section 2-113 of the Providence Code of Ordinances, it is the duty of the Director of Public Property to superintend work on streets and sidewalks, including cleaning; and

**WHEREAS**, However, proper and regular cleaning of sidewalks has not been completed consistently; and

**WHEREAS**, As public servants and the elected representatives of the people of Providence, the City Council has an obligation to ensure that sidewalks are maintained in appropriate condition.

**NOW, THEREFORE, BE IT RESOLVED**, That the Providence City Council hereby requests that the Director of Public Works clean all debris and sweep sidewalks along the along the Providence Business Corridors.

**BE IT FURTHER RESOLVED**, That, upon passage, copies of this resolution will be sent to the Mayor of Providence, and the Director Public Works.

Resolution Requesting the Director of Public Works and the City Engineer repair the guardrail at Chalkstone Avenue and Ortoleva Drive.

**WHEREAS**, Chalkstone Avenue is a major street in the City of Providence and runs by Pleasant View Elementary School; and

**WHEREAS**, At the intersection of Chalkstone Avenue and Ortoleva Drive, there is a guardrail that is broken and in need of repair; and

**WHEREAS**, Due to the guardrail's location down the street from an elementary school and in a residential area, it is of the utmost importance to repair the guardrail as an assurance of safety; and

**WHEREAS**, As the elected representatives of the people of Providence, the Providence City Council has a duty to ensure that the City's roads have the proper protections necessary to ensure the safety of its residents, particularly the safety of Providence students.

**NOW, THEREFORE, BE IT RESOLVED**, That the City Council of the City of Providence does hereby request the Director of Public Works and the City Engineer repair the guardrail at Chalkstone Avenue and Ortoleva Drive.

Resolution Requesting further consideration of Prospect CharterCARE LLC's Business Practices.

**WHEREAS**, CharterCARE Health Partners (“CharterCARE”) operates a healthcare system in the City of Providence and the Town of North Providence which includes Roger Williams Medical Center and St. Joseph’s Health System of Rhode Island and Our Lady of Fatima Hospital (“Fatima Hospital”); and

**WHEREAS**, The CharterCARE healthcare system has considerable economic impact on the City of Providence and the State of Rhode Island; and

**WHEREAS**, Approximately 550 of CharterCARE’s employees reside in the City of Providence; and

**WHEREAS**, Recently, CharterCARE entered into an agreement to form a partnership with Prospect Medical Holdings, Inc. (Prospect), creating a new healthcare system called Prospect CharterCARE, LLC (“New Hospitals” or “Prospect CharterCARE”); and

**WHEREAS**, As a result of the for-profit hospital conversion, the City of Providence no longer receives payments in lieu of taxes and thus executed a tax stabilization and exemption treaty with Prospect CharterCARE; and

**WHEREAS**, However, since January 2019, members of Local 5110 of the United Nurses and Allied Professionals (“UNAP”) at Fatima Hospital have protested Prospect CharterCARE to bring attention to their “abhorrent record on patient and worker safety”; and

**WHEREAS**, According to the President of UNAP Local 5110, Cindy Fenchel UNAP members have filed 150 incident reports with the Fatima Hospital since 2016; and

**WHEREAS**, According to UNAP, a 2017 internal review of Fatima Hospital’s operating rooms revealed serious deficiencies related to surgical instruments and procedures; and

**WHEREAS**, Due to frustration with the work environment and concern about the safety of patients and workers at Fatima Hospital, the UNAP Local 5110 membership voted in March to authorize issuance of a 10-day strike notice, “if necessary”; and

**WHEREAS**, Additionally, according to a Providence Journal story dated March 15, 2019, the National Labor Relations Board found that Prospect CharterCARE violated federal law by withholding patient- and worker-safety information; and

**WHEREAS**, Providence Journal Reporter G. Wayne Miller reported that Administrative Law Judge Donna N. Dawson found Prospect in violation of the law as they did not provide the Local 5110 access to a survey that disclosed inferior operating-room conditions; and

**WHEREAS**, As the elected representatives of the people of the City of Providence, the City Council has a duty and obligation to ensure that any agreements for subsidies between the City and for-profit entities includes good faith efforts towards the communities and employees of the institute receiving subsidies.

**NOW, THEREFORE, BE IT RESOLVED**, That the Providence City Council urges CharterCare Health Partners to remedy any and all issues related to patient and employee safety at Fatima Hospital.

**BE IT FURTHER RESOLVED**, That the City Council of the City of Providence does hereby request that all future re-negotiations of subsidies, tax stabilizations, or exemptions with Prospect CharterCARE take into consideration the entity’s efforts to engage their employees, patients, and the community in a safe and transparent manner.
