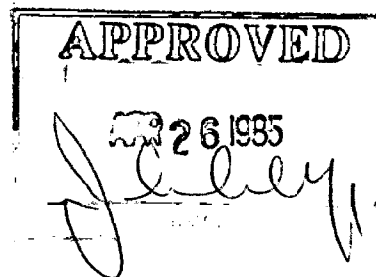
Approved April 26, 1985

Dear Ms. Brassil:

The 1985 Brown University Spring Weekend Activities are slated for Wednesday through Sunday, April 24th, 25th, 26th, 27th and 28th. I am requesting your assistance and approval for the following street closings which will assist in making the planned activities much safer due to the number of people in the area.

On Friday 26 April I am requesting that Thayer Street be closed from Waterman Street South to George Street during the hours of 6:30am until 7:00pm. This would accomodate the heavy pedestrian traffic flow in the area.


