
Gentlemen:

The Traffic Engineering Department has investigated the request contained in Council Resolution No. 623 dated December 7, 1956, relative to the advisability of the installation of a traffic signal light and pedestrian crosswalk markings on Broadway at Courtland Street.

The investigation indicates that pedestrian crosswalk markings are desirable at this location, and they will therefore be added to the pavement marking program.

This study further indicates that as a result of the volume of traffic desiring to enter or cross Broadway from Courtland Street as well as the number of accidents that have taken place involving vehicles or pedestrians entering or crossing Broadway from Courtland Street that a traffic signal cannot be justified at this location at this time.



Gentlemen:

The Traffic Engineering Department has studied resolution No. 607 dated November 16, 1956, relative to conditions on crosswalks leading from Exchange Street across Dyer Street, South Water Street, and South Main Street to the Superior Court House Building with a view for providing more adequate protection for pedestrians using these crosswalks.

There is no question of the importance of these three crosswalks as far as pedestrian use is concerned. All three of these crosswalks are used extensively; and all three are in effect midblock crosswalks, which tends to aggravate the problem. The problem is further aggravated by the relative location of these three crosswalks with respect to the over-all traffic movements through the Market-Memorial Square area. The Market-Memorial Square area serves as one of the major keys to traffic movement in the entire central area of Providence, in that whenever any congestion develops in the Market-Memorial Square area, it has an almost immediate influence on other major segments of traffic movement in the City, namely, Exchange Place, Pershing Square, as well as the central business district. For this reason any changes that are made in the traffic movement and controls in the Market-Memorial Square area must be made with this thought in mind, so that the change does not create added congestion and therefore effect the fluid movement of the entire central business area.


At the same time it is recognized that the protection of pedestrians on any major crosswalks is of utmost importance, and any possible protection that can be provided should be provided. Some time ago an island was introduced on Dyer Street with a special sign indicating "Stop for Pedestrians." This type of control has worked fairly satisfactorily since it was introduced. A similar type of island and sign was studied for use on South Water Street at that same time, but it was not installed due to the differences in traffic movement on the two streets. We have restudied the possible use of such a sign on South Water Street; and although it will create certain difficulties with respect to the traffic movement, it is felt that it should be tried on the ground. Therefore, as soon as weather conditions permit, a painted island and a street sign

indicating "Stop for Pedestrians" will be installed at the crosswalk on South Water Street. The street width on South Main Street precludes the use of any similar-type sign or island within the street area of South Main Street. However, similar-type signs can be installed along the sidewalk on South Main Street for additional pedestrian emphasis to motorists.

As construction of the first phase of the North-South Freeway is completed, South Main Street is planned to be a one-way artery leading from the Freeway at Wickenden Street to the Market-Memorial Square area, and South Water Street will be one way southbound leading from Crawford Bridge to the Freeway area. On the other side of the river, Dyer Street, as we presently know it, will be one way southbound to Dorrance Street; and a new Dyer Street will be constructed along the river face leading from the new bridge to Crawford Bridge. These changes in roadway location will result in a major change in the crossing pattern taking place on Crawford Bridge and will result in the necessity for signaling this crossing. This signal will provide an immediate benefit to the pedestrians crossing South Water Street, in that a gap in the traffic stream will be provided. This gap will result in a relatively safe interval in which pedestrians should cross South Water Street. Any serious consideration of further signalization of these pedestrian crosswalks should be postponed until after these major changes in highway use have taken place and the signal at Crawford Bridge has been operating for a sufficient length of time to determine the operating effects on the traffic movement in the entire Market-Memorial Square area.




