IN GENERAL ASSEMBLY

JANUARY SESSION, A. D. 19 75

AN ACT

RELATING TO THE ZONING BOARD OF REVIEW
OF THE CITY OF PROVIDENCE.

It is enacted by the General Assembly as follows:

SECTION 1. Section 45-24-14 in chapter 45-24 of the general laws entitled "Zoning ordinances" is hereby amended to read as follows:

"45-24-14. Composition of board of review - Open hearings. -

"* * * :

"Provided further, however, that in addition to the membership of the board of review of the city of Providence, said board shall consist of two (2) additional members. Each of said additional members of the board of review of the city of Providence shall be members of the city council elected to said board forthwith after the effective date of this act by the city council from its councilmatic members to serve ~~for a term of five (5) years as long as he holds office.~~ The board of review of the city of Providence shall elect a chairman and a secretary from its membership.

SEC. 2. Nothing herein contained shall in any way effect or alter any other part or provision of this title, chapter, or section, or any appointments heretofore or hereafter made thereunder, all of which remain in full force and effect.

SEC. 3. This act shall take effect upon its passage.

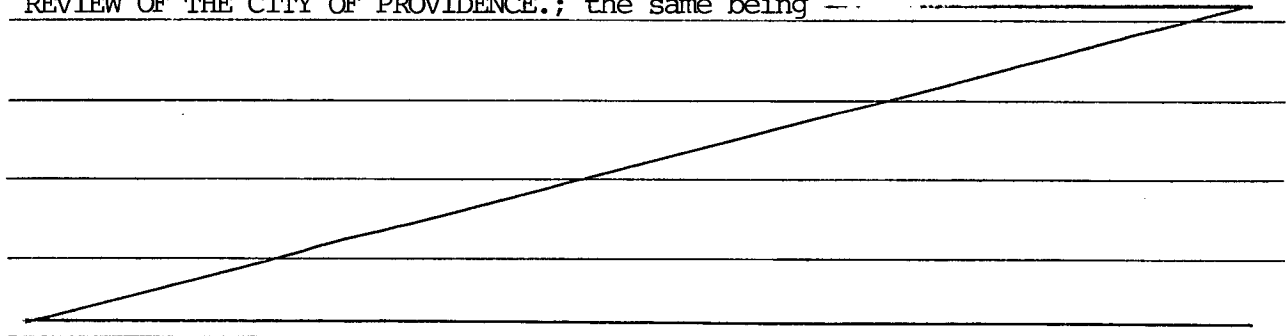

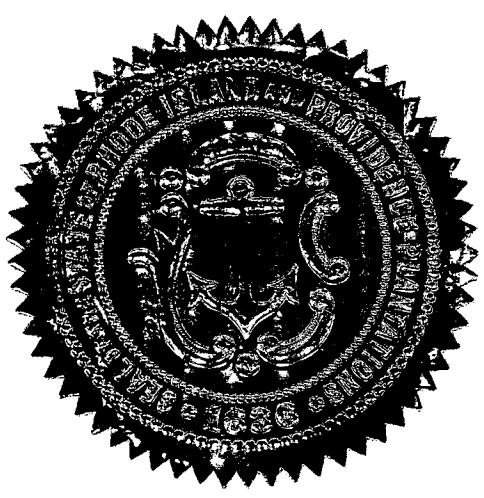
